SLAUGHTER-HOUSES

Slaughter-houses (Metrication) Regulations (Northern Ireland) 1976

. 14th December 1976 Made Coming into operation . 3rd January 1977

The Department(a) of Agriculture in exercise of the powers conferred on it by Section 11(1) of the Slaughter-houses Act (Northern Ireland) 1953(b) and of every other power enabling it in that behalf hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Slaughter-houses (Metrication) Regulations (Northern Ireland) 1976 and shall come into operation on 3rd January 1977.

Amendment of the Slaughter-houses (Licensing) Regulations (Northern Ireland) 1955

- 2.—The Slaughter-houses (Licensing) Regulations (Northern Ireland) 1955(c) are hereby amended as follows:—
 - (1) In the First Schedule
 - for "5 ft" there shall be substituted "1.5 m";
 - for "4 ft" on each occasion where it occurs there shall be substituted "1.25 m";
 - for "12 ft" there shall be substituted "4 m";
 - for "31 ft" there shall be substituted "1 m";
 - for "6 ft" there shall be substituted "2 m";
 - for "18 ins" on each occasion where it occurs there shall be substituted "0.5 m";
 - for "10 ft" there shall be substituted "3 m":
 - for "15 ft" on each occasion where it occurs there shall be substituted "4.5 m":
 - for "19 ft" there shall be substituted "5.75 m".
 - (2) In the Second Schedule
 - for "4 ft" on each occasion where it occurs there shall be substituted "1.25 m";
 - for "6 ins" there shall be substituted "15 cm":
 - for "4½ ins" there shall be substituted "12 cm";
 - for "5 sq ft" there shall be substituted "0.5 sq m";
 - for "5 ft" there shall be substituted "1.5 m";
 - for "8 ft" there shall be substituted "2.5 m";
 - for "42 ins" there shall be substituted "107 cm";
 - for "32 ins" there shall be substituted "82 cm".

(3) In the Fourth and Fifth Schedules for "200 lb" on each occasion where it occurs there shall be substituted "90 kg".
