**The Poultry (Feed Price Allowance) (Amendment No. 2) Scheme
(Northern Ireland) 1979**

Made 22nd June 1979

Coming into operation 1st July 1979

The Department of Agriculture, in exercise of the powers conferred by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department(b) of Finance, hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Poultry (Feed Price Allowance) (Amendment No. 2) Scheme (Northern Ireland) 1979 and shall come into operation on 1st July 1979.

*Amendment to the Poultry (Feed Price Allowance) Scheme
(Northern Ireland) 1971*

2. The Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971(c) is amended as follows:—

In Article 3 for “£8.5 million” there shall be substituted “£9.5 million” and for “30th June 1979” there shall be substituted “31st March 1980”.

Revocation

3. The Poultry (Feed Price Allowance) (Amendment) Scheme (Northern Ireland) 1979(d) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme amends the Poultry (Feed Price Allowance) Scheme (Northern Ireland) 1971 which provides for payments to the poultry producers of Northern Ireland to assist them towards meeting the cost of poultry feed. It extends the life of the Scheme from 30th June 1979 to 31st March 1980 and increases from £8.5 million to £9.5 million the maximum amount which can be paid in total under the poultry, eggs and pigs feed price allowance schemes.
