Factories (Hours of Employment) (Revocation and Amendment) Order (Northern Ireland) 1989

Whereas the Department of Economic Development ("the Department") considers the provision contained in this Order to be appropriate in consequence of Article 12(1) to (3) of the Sex Discrimination (Northern Ireland) Order 1988(a) ("the 1988 Order");

Now, therefore, the Department in exercise of the powers conferred on it by Article 12(5) of the 1988 Order and of every other power enabling it in that behalf, hereby makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Factories (Hours of Employment) (Revocation and Amendment) Order (Northern Ireland) 1989, and shall come into operation on 1st December 1989.
- (2) In this Order "the 1965 Act" means the Factories Act (Northern Ireland) $1965(\mathbf{b})$.

Revocations and amendments

- 2. Insofar as they are still in force the following Regulations are hereby revoked:
 - Factories (Manufacture of Bread, Biscuits and Flour Confectionery Overtime) Regulations (Northern Ireland) 1939(c);
 - -- Factories (Laundries -- Overtime) Regulations (Northern Ireland) 1939(d).

Factories EXPLANATORY NOTE

(This note is not part of the Order.)

This Order revokes various instruments and amends others, which were made under the Factories Act (Northern Ireland) 1938 and other legislation but have effect as if made under the Factories Act (Northern Ireland) 1965. The revocations and amendments are made in consequence of the removal by the Sex Discrimination (Northern Ireland) Order 1988 of certain restrictions on the working hours and conditions of women in factories.
