**The Occupational Pensions (Revaluation)  
Order (Northern Ireland) 2000**

*Made - - - - 24th November 2000*

*Coming into operation 1st January 2001*

Whereas the Secretary of State for Social Security has made an Order<sup>(1)</sup> under paragraph 2(1) of Schedule 3 to the Pension Schemes Act 1993<sup>(2)</sup>:

Now, therefore, the Department for Social Development, in exercise of the powers conferred by paragraph 2(1) of Schedule 2 to the Pension Schemes (Northern Ireland) Act 1993<sup>(3)</sup> and now vested in it<sup>(4)</sup>, and of all other powers enabling it in that behalf, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Occupational Pensions (Revaluation) Order (Northern Ireland) 2000 and shall come into operation on 1st January 2001.

(2) The Interpretation Act (Northern Ireland) 1954<sup>(5)</sup> shall apply to this Order as it applies to an Act of the Assembly.

**Revaluation percentage for each revaluation period**

2. For the purposes of paragraph 2(1) of Schedule 2 to the Pension Schemes (Northern Ireland) Act 1993, the revaluation percentage for each revaluation period specified in column 1 of the Schedule is the percentage specified opposite thereto in column 2.
