**ROAD TRAFFIC**

The A80 Trunk Road (Haggs to Bankhead) (Temporary 40mph Speed Restriction)  
Order 2009

*Made*  
*Coming into force*

*7th August 2009*  
*1st September 2009*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 14(1) and (4), 2(1) and 2(2) and 4(1) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted because works are being or are proposed to be executed on or near those lengths of road.

In accordance with section 14(3) of that Act, they have regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A80 Trunk Road (Haggs to Bankhead) (Temporary 40mph Speed Restriction) Order 2009, comes into force on 1st September 2009 and ceases to have effect at midnight on 28th February 2011.

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

## **Temporary speed restriction**

2. No person shall drive any vehicle on the lengths of road specified in the Schedule at a speed exceeding 40mph when a restriction is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations<sup>(a)</sup>.

## **SCHEDULE**

1. That length of the A80 Glasgow-Stirling Trunk Road from Station Road Overbridge, Hags to its junction (Junction 5 Bankhead) with the M876 Trunk Road, a distance of 457 metres or thereby.
2. That length of the M876 Dennyloanhead–Gartarry Roundabout Trunk Road from Denny Road Overbridge, Dennyloanhead to its junction with the M80 Trunk Road, a distance of 411 metres or thereby.
