



## CHAPTER lxx

An Act to confirm a Provisional Order under the Private Legislation Procedure (Scotland) Act 1936 relating to Aberdeen Harbour. [2nd August 1956.]

**W**HEREAS the Provisional Order set forth in the schedule hereunto annexed has been made by the Secretary of State under the provisions of the Private Legislation Procedure (Scotland) Act 1936 and it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The Provisional Order contained in the schedule hereunto annexed is hereby confirmed.

2. This Act may be cited as the Aberdeen Harbour Order Confirmation Act 1956.

## SCHEDULE

## ABERDEEN HARBOUR

*Provisional Order to extend the period of duration of the Aberdeen Harbour Acts 1895 to 1953.*

WHEREAS by the Aberdeen Harbour Act 1895 (hereinafter referred to as "the Act of 1895") the Acts then in force relating to the harbour of Aberdeen were consolidated with amendments and the Aberdeen Harbour Commissioners (hereinafter referred to as "the Commissioners") were constituted:

And whereas by the Aberdeen Harbour Acts 1895 to 1953 (hereinafter referred to as "the Harbour Acts") further powers were conferred on the Commissioners:

And whereas among the Acts consolidated by the Act of 1895 was the Aberdeen Harbour Act 1868 of which section 2 (Firstly recited Act and part of secondly recited Act repealed; Commencement and Duration of this Act) enacted that that Act should continue in force for the space of fifty-five years namely until the first day of October one thousand nine hundred and twenty-three and from thence to the end of the then next session of Parliament and of which section 183 (Upon the Expiration of this Act the Property of the Harbour to revert to the Council) enacted that upon the expiration of that Act the property of the harbour undertaking should revert to or become the property of the lord provost magistrates and town council of the city and royal burgh of Aberdeen (hereinafter referred to as "the council"):

And whereas at the date of the passing of the Act of 1895 there were twenty-eight years of the said period of fifty-five years unexpired and section 199 (Saving rights &c. of the council) of the Act of 1895 enacted inter alia that the council should not less than three years before the expiration of the said period of twenty-eight years apply to Parliament for an Act to determine and regulate the administration of the harbour undertaking:

And whereas by subsequent enactments the said period was extended and became due to expire on the first day of April one thousand nine hundred and fifty-six:

And whereas by section 2 (Harbour Acts to continue in force until 1959) of the Aberdeen Harbour Order 1953 (hereinafter referred to as "the Order of 1953") the period expiring on the first day of April one thousand nine hundred and fifty-six was extended until the first day of April one thousand nine hundred and fifty-nine:

And whereas it is expedient that the Order of 1953 should be amended and the period of duration of the Harbour Acts should again be extended as provided in this Order:

And whereas the purpose aforesaid cannot be effected without an Order confirmed by Parliament under the Private Legislation Procedure (Scotland) Act 1936:

Now therefore in pursuance of the powers contained in the last-mentioned Act the Secretary of State orders as follows:—

1. This Order may be cited as the Aberdeen Harbour Order 1956 and this Order and the Aberdeen Harbour Acts 1895 to 1953 may be cited together as the Aberdeen Harbour Acts 1895 to 1956. Short title and citations.

2. Section 2 (Harbour Acts to continue in force until 1959) of the Order of 1953 shall be read and have effect as if for subsection (1) thereof there were substituted the following subsection (namely):— Amendment of Aberdeen Harbour Order 1953.

“(1) The period of duration of the Harbour Acts shall be extended and the provisions of those Acts shall remain in force until the first day of April one thousand nine hundred and sixty and section 199 (Saving rights &c. of the council) of the Act of 1895 shall be read and have effect as if for the period mentioned in subsections (2) and (3) of that section as amended by the Order of 1949 there were substituted a reference to a period of sixty-five years from the first day of April one thousand eight hundred and ninety-five and as if the word ‘sixty-five’ had been inserted in place of the word ‘sixty-one’ twice occurring in subsection (4) of the said section as amended by the Order of 1949.”

3. All costs charges and expenses of and incident to the preparing for obtaining passing and confirming of this Order or otherwise in relation thereto shall be paid by the Commissioners from and out of the revenues of their harbour undertaking. Costs of Order.
