# GEORGI III. REGIS.



## Cap. 205.

An Act for repealing an Act of His present Majesty, for repairing and maintaining the Road from the Eynesford Turnpike Road in the Parish of Shoreham in the County of Kent, to the Turnpike Road in the Parish of Farnborough, leading from Seven Oaks to Bromley, in the said County. [26th June 1811.]

**W**HEREAS by an Act passed in the Fiftieth Year of the Reign of His present Majesty, intituled, *An Act for repairing and maintaining the Road from the Eynesford Turnpike Road in the Parish of Shoreham in the County of Kent, to the Turnpike Road in the Parish of Farnborough, leading from Seven Oaks to Bromley, in the said County,* certain Persons were thereby appointed Trustees for amending, widening, turning, altering, and keeping in Repair the Road from the Eynesford Turnpike Road in the Parish of Shoreham in the County of Kent, to the Village of Chelsfield over Grinstead Green in the Parish of Farnborough, and to the Turnpike Road leading from Seven Oaks to Bromley in the said County, according to the Provisions and Directions in the said recited Act contained: And whereas the several Powers and Provisions contained in the said recited Act, if acted upon, can never be of any real public Utility, but must be attended with a very great and heavy Expence,

which cannot be reimbursed out of the Tolls directed to be levied or collected by virtue of the said recited Act, and some of the said Powers and Provisions if acted upon, would be highly injurious to some of the Proprietors of Houses and Lands near or through which the said Road is intended to pass: It is therefore expedient that the said recited Act, and the several Clauses and Provisions therein contained, should be repealed; May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That, from and immediately after the passing of this Act, the said recited Act, and all and every the Powers, Clauses, Provisions, Penalties, Forfeitures, Regulations, Matters and Things therein expressed and contained, shall be and the same is and are hereby repealed, and declared to be null and void to all Intents and Purposes whatsoever.

II. And be it further enacted, That this Act shall be deemed and taken to be a Public Act; and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.
