



## CHAPTER xvi.

An Act to confirm certain Provisional Orders of the Minister of Health relating to Felixstowe Folkestone Sheffield Stourbridge Widnes and Wolverhampton. [14th July 1924.]

**W**HEREAS the Minister of Health has made the Provisional Orders set forth in the schedule hereto under the provisions of the Public Health Act 1875:

And whereas it is requisite that the said Orders should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The Orders set out in the schedule hereto shall be and the same are hereby confirmed and all the provisions thereof shall have full validity and force.

2. This Act may be cited as the Ministry of Health Provisional Orders Confirmation (No. 4) Act 1924.

**URBAN DISTRICT OF FELIXSTOWE.**

*Provisional Order for amending the Felixstowe  
and Walton Improvement Act 1902.*

WHEREAS the Urban District Council of Felixstowe (hereinafter referred to as "the Council") are the local authority for the purposes of the Public Health Act 1875 for the Urban District of Felixstowe and the unrepealed provisions of the Felixstowe and Walton Improvement Act 1902 (hereinafter referred to as "the Local Act") are in force in that District;

And whereas under Section 41 of the Local Act the Council have certain powers with respect to public bands of music;

And whereas the Council have made application to the Minister of Health for the issue of a Provisional Order to amend the Local Act in the manner hereinafter set forth:

Now therefore the Minister of Health in pursuance of the powers given to him by Section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders that from the date of the Act of Parliament confirming this Order the Local Act shall be amended as follows:—

Application of receipts from letting of sites for bathing cabins as contribution towards bands.

Short title.

1. In addition to any other moneys which the Council may apply towards the provision of public bands of music the Council may so apply any moneys received by them from letting for bathing cabins and bathing tents such sites as they may for the time being be entitled to let for that purpose.

2. This Order may be cited as the Felixstowe Order 1924.

**BOROUGH OF FOLKESTONE.**

*Provisional Order for partially repealing and altering  
the Folkestone Corporation Act 1901 and the  
Folkestone Corporation Act 1920.*

*Folkestone

WHEREAS so much of the Borough of Folkestone (hereinafter referred to as "the Borough") as is not included in the Urban District of Sandgate is an Urban District of which the Mayor Aldermen and Burgesses acting by the Council (hereinafter referred to as "the Corporation") are the Local Authority for the purposes of the Public Health Acts and the unrepealed provisions of the Folkestone Corporation Act 1901 and the Folkestone Corporation Act 1920 (each of which Acts is hereinafter referred to as the Act of the year in which it was passed) are in force in the Borough;

And whereas by Section 6 of the Act of 1901 and Section 80 of the Act of 1920 provision was made with regard to the audit of the accounts of the Corporation and their officers;

And whereas the Corporation have applied to the Minister of Health for the issue of a Provisional Order partially to repeal and alter the Act of 1901 and the Act of 1920 in manner hereinafter appearing:

Now therefore the Minister of Health in pursuance of the powers given to him by Section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders that from and after the date of the Act of Parliament confirming this Order the Act of 1901 and the Act of 1920 shall be partially repealed and altered so that the following provisions shall take effect that is to say:—

1. This Order may be cited as the Folkestone Order 1924. Short title.
2. Section 6 of the Act of 1901 and Section 80 of the Act of 1920 are hereby repealed. Repeal.
- 3.—(1) Sections 25 26 and 27 of the Municipal Corporations Act 1882 and Section 246 of the Public Health Act 1875 shall not apply to the accounts of the Corporation or of the treasurer of the Borough or of the officers of the Corporation for the financial year ending the Thirty-first day of March Nineteen hundred and twenty-six or for any later financial year. Audit of

(2) All such accounts whether under any public or any local Act or otherwise relating to matters dealt with by the Corporation in any capacity shall be made up and audited in like manner as the accounts of an urban authority for the execution of the Public Health Acts (not being the council of a borough) and of their officers are made up and audited and shall be in such form as the Minister of Health may prescribe.

(3) This Article shall extend to the accounts for any financial year mentioned in subdivision (1) of this Article of any joint committee appointed by the Corporation with any other council (and of the officers of any such joint committee) and notwithstanding anything in the Folkestone Port Order 1922 to the accounts for any such financial year of the Corporation as the port sanitary authority for the Port of Folkestone and of the officers of such authority.

(4) Sections 247 and 250 of the Public Health Act 1875 Section 58 of the Local Government Act 1894 and all enactments amending those Sections or relating to the accounts and audit by district auditors of the accounts of an urban authority (not being the council of a borough) and of their officers shall apply for the purposes of this Order as if they were herein re-enacted with the necessary modifications.

4. The Corporation may out of the borough fund defray reasonable expenditure incurred by them upon any of the following purposes:—

- (1) annual or other subscriptions to the funds of any association of municipal corporations or other local authorities or their officers formed for the purpose of consultation as to their common interests and the discussion of matters relating to local government;
- (2) the attendance of any members or officers of the Corporation (not exceeding in any case four) at conferences or meetings of any such association and in the purchase of reports of the proceedings of any such conferences or meetings;
- (3) in connection with the presentation of the freedom of the Borough to persons whom the Corporation may resolve to admit as honorary freemen;
- (4) in connection with occasions of public ceremony or festival or in the reception or entertainment of distinguished persons or persons attending any conference or meeting held in the Borough and convened by any association or society;
- (5) in connection with the installation of a Lord Warden of the Cinque Ports or any other ceremony proceeding or matter in which the Corporation have been accustomed to take part as a limb or member of the Cinque Ports; or
- (6) the attendance of members of the fire brigade of the Corporation at meetings and competitions of fire brigades.

5. The purposes to which the borough fund is by law applicable as extended by Part IX. of the Act of 1920 shall include the provision of a working balance for the payment of current expenses which may be incurred by the Corporation in the exercise or performance of the powers and duties the cost of which is chargeable on the borough fund and the Corporation in estimating the amount sufficient for those purposes and in ordering a borough rate to be made may from time to time include such a sum as they may consider to be necessary towards the provision of such a working balance.

CITY OF SHEFFIELD.

*Provisional Order for altering or amending the Sheffield  
Corporation (Consolidation) Act 1918.*

*Sheffield  
Order.*

WHEREAS the City of Sheffield (hereinafter referred to as "the City") is an urban sanitary district of which the Lord Mayor Aldermen and Citizens acting by the Council (hereinafter referred to as "the Corporation") are the local authority and the unrepealed provisions of the Sheffield Corporation (Consolidation) Act 1918 (hereinafter referred to as "the Local Act") are in force in the City;

And whereas by Section 249 of the Local Act the Corporation may from time to time sell lease exchange or otherwise dispose of in such manner and for such consideration as they may think fit any lands or any interest in lands which are vested in used held or enjoyed by them or which may be acquired or become vested in them;

And whereas Section 296 of the Local Act makes provision with reference to crossings for horses or vehicles over footways;

And whereas Section 338 of the Local Act provides that where two or more houses or premises are connected with a single private drain which conveys their drainage into a public sewer or into a cesspool or other receptacle for drainage the Corporation shall have all the powers conferred by Section 41. of the Public Health Act 1875;

And whereas the Corporation have made application to the Minister of Health for the issue of a Provisional Order to alter or amend the Local Act in the manner hereinafter set forth:

Now therefore the Minister of Health in pursuance of the powers given to him by Section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders that from and after the date of the Act of Parliament confirming this Order the Local Act shall be altered and amended so that the following provisions shall take effect that is to say:—

1. In relation to the lands described in the Schedule to this Order the Corporation may in addition to or in lieu of exercising the powers conferred by Section 249 of the Local Act but subject to any covenant or condition in any lease conveyance or agreement relating to the said lands exercise all or any of the following powers that is to say the Corporation may—

- (a) at any time set apart any part or parts of the said lands and may adapt the same for the purpose of any game recreation contest match or pastime;
- (b) for any such purpose let the same on lease or otherwise to any club or person;
- (c) make or authorise any such club or person to make reasonable charges for the use of or access to any part so set apart;
- (d) provide erect manage maintain remove or let to any club or person or agree with any club or person for the provision erection management maintenance or removal of any pavilions buildings works and conveniences on the said lands or in connection therewith and charge or authorise any club or person to charge for admission thereto or in respect of the use thereof; and
- (e) exclude the public from the parts of the said lands so set apart and from such pavilions buildings works and conveniences.

2. Subject to the provisions of this Order the said lands shall be deemed to be a pleasure ground purchased by the Corporation under the provisions of Section 164 of the Public Health Act 1875.

3. Section 296 of the Local Act shall be altered by the insertion of the words "or using" immediately after the words "desirous of forming" and by the insertion immediately after the words "to the surveyor" of the words "or shall comply with such other conditions as the Corporation in any case require."



4. Section 338 of the Local Act shall be altered by the insertion of the words " and Section 45 of the Public Health Acts Amendment Act 1907 " immediately after the words " Public Health Act 1875 " and before the words " and the Corporation " and by the substitution of the words " by those sections " for the words " by that section. "

WHEREAS the Borough of Stourbridge (hereinafter referred to as "the Borough") is an Urban District of which the Mayor Aldermen and Burgesses acting by the Council (hereinafter referred to as "the Corporation") are the local authority for the purposes of the Public Health Act 1875 and the unrepealed provisions of the Stourbridge Improvement Act 1866 (hereinafter referred to as "the Local Act") are in force in the Borough;

And whereas Section 52 of the Local Act incorporates certain provisions of the Towns Improvement Clauses Act 1847 (hereinafter referred to as "the Act of 1847") and the Corporation propose to make new byelaws under the Public Health Acts the subject-matter of which will be cognate to the subject-matter of certain of the said provisions of the Act of 1847;

And whereas certain other of the said provisions of the Act of 1847 are covered by certain provisions of the Public Health Act 1875;

And whereas the Corporation have accordingly made application to the Minister of Health for the issue of a Provisional Order partially to repeal the Local Act in the manner hereinafter set forth:

Now therefore the Minister of Health in pursuance of the powers given to him by Section 303 of the Public Health Act 1875 and of any other powers in that behalf hereby orders that from and after the date of the Act of Parliament confirming this Order the following provisions shall have effect that is to say:—

1. This Order shall come into operation on the First day of January One thousand nine hundred and twenty-five or on such earlier date on which new byelaws of the Corporation with respect to new streets and buildings shall come into force.

2. So much of Section 52 of the Local Act as incorporates Sections 13 to 18 (inclusive) 22 to 46 (inclusive) 61 to 63 (inclusive) and 109 to 115 (inclusive) of the Act of 1847 shall be repealed.

*Provisional Order to enable the Widnes Corporation to  
put in force the Compulsory Clauses of the

WHEREAS the Mayor Aldermen and Burgesses of the Borough  
of Widnes (hereinafter referred to as "the Corporation") acting  
by the Council as the local authority for that Borough for the  
purposes of the Public Health Act 1875 require to purchase  
and take the lands described in the Schedule hereto for the  
purposes of widening opening enlarging or otherwise improving  
the streets known as Mersey Road and St. Mary's Road in the  
said Borough :

Now therefore the Minister of Health in pursuance of the  
powers given to him by Section 176 of the Public Health Act  
1875 and by any other Statutes in that behalf hereby orders  
that from and after the date of the Act of Parliament confirming  
this Order the following provisions shall have effect that is to  
say :—

1. The Corporation shall be empowered for the purposes  
aforesaid to put in force with reference to the lands described  
in the Schedule hereto (subject to the continuance of existing  
public rights of highway if any) the powers of the Lands Clauses  
Acts as modified by the Acquisition of Land (Assessment of  
Compensation) Act 1919 with respect to the purchase and taking  
of lands otherwise than by agreement or any of them.

And whereas by Article X. of the Order of 1896 the Corporation were authorised to borrow with the sanction of the Local Government Board such sums not exceeding in the whole the sum of thirty-five thousand pounds as might from time to time be necessary for the purposes therein mentioned;

And whereas the Corporation have made application to the Minister of Health for the issue of a Provisional Order partially to alter or amend the Order of 1896 in the manner hereinafter set forth:

Now therefore the Minister of Health in pursuance of the powers given to him by Sections 297 and 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders that from and after the date of the Act of Parliament confirming this Order the Order of 1896 shall be altered in manner following that is to say:—

1. Article X. of the Order of 1896 shall be altered and have effect as if the words "forty-six thousand pounds" were therein substituted for the words "thirty-five thousand pounds."
