



CHAPTER lxxxi.

An Act to confirm certain Provisional Orders of the Minister of Health relating to Bury Saint Edmund's Hastings Northampton Paignton Poole and Sheffield. [7th August 1925.]

A.D. 1925.

WHEREAS the Minister of Health has made the Provisional Orders set forth in the schedule hereto under the provisions of the Public Health Act 1875 :
