CHAPTER lxxvii.

An Act to confirm certain Provisional Orders of the Local Government Board under the provisions of the Highways and Locomotives (Amendment) Act, 1878, relating to the Counties of Buckingham, Kent, and Worcester.

[3d July 1879.]

HEREAS the Local Government Board have made the Provisional Orders set forth in the schedule hereto annexed, under the provisions of the Highways and Locomotives (Amendment) Act, 1878, and it is requisite that the said Orders should be confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The Orders set out in the schedule hereto annexed shall be The Orders and the same are hereby confirmed, and all the provisions thereof in schedule confirmed. shall, from and after the passing of this Act, have full validity and force.

COUNTY OF BUCKINGHAM.

Provisional Order for declaring that certain Disturnpiked Roads ought not to become Main Roads.

To the Justices of the County of Buckingham in General or Quarter Sessions assembled, being the County Authority for that County within the meaning of the Highways and Locomotives (Amendment) Act, 1878;—

And to all others whom it may concern.

WHEREAS by Section 13 of the Highways and Locomotives (Amendment) Act, 1878, it is enacted that for the purposes of that Act, and subject to its provisions, any road which has, within the period between the Thirty-first day of December, One thousand eight hundred and seventy, and the date of the passing of that Act, ceased to be a turnpike road, and any road which, being at the time of the passing of that Act a turnpike road, may afterwards cease to be such, shall be deemed to be a Main Road;

And whereas by Section 16 of the same Act it is also enacted that if it appears to a County Authority that any road within their County which, within the period between the Thirty-first day of December, One thousand eight hundred and seventy, and the date of the passing of that Act, ceased to be a turnpike road, ought not to become a Main Road in pursuance of that Act, such Authority shall, before the First day of February, One thousand eight hundred and seventy-nine, make an application to the Local Government Board for a Provisional Order declaring that such road ought not to become a Main Road; and that the Local Government Board, if of opinion that there is probable cause for an application under that section, shall cause the road to be inspected, and, if satisfied that it ought not to become a Main Road, shall make a Provisional Order accordingly;

And whereas the roads in the County of Buckingham herein-after referred to were included amongst the roads to be repaired, maintained, and improved under the provisions of a Local Act of Parliament passed in the sixth year of the reign of His Majesty King George the Fourth, and intituled "An Act for "more effectually repairing and improving certain roads passing through Princes "Risborough, in the County of Buckingham, and communicating with "Aylesbury and Great Marlow, in the said County, and Thame, in the "County of Oxford";

And whereas, in pursuance of the provisions of the Annual Turnpike Acts Continuance Act, 1871, the said Local Act expired on the First day of November, One thousand eight hundred and seventy-one, and the roads herein-

after referred to ceased to be Turnpike Roads within the period between the Thirty-first day of December, One thousand eight hundred and seventy, and the date of the passing of the said Highways and Locomotives (Amendment) Act, 1878, viz., the Sixteenth day of August, One thousand eight hundred and seventy-eight;

And whereas it appeared to the County Authority for the County of Buckingham that the said roads ought not to become Main Roads, and the said County Authority accordingly made application to the Local Government Board before the First day of February, One thousand eight hundred and seventy-nine, for a Provisional Order to declare that such roads ought not to become Main Roads;

And whereas the Local Government Board, being of opinion that there was probable cause for such application, caused the said roads to be inspected, and are satisfied that such roads ought not to become Main Roads:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the said Highways and Locomotives (Amendment) Act, 1878, do, by this Order, declare that the roads described in the said Local Act as "the road leading from and out of the London and Oxford Turnpike "Road, near the thirty-one milestone" in the Parish of West Wycombe, "by or "near to a place called Crispin's Chapel, to Bottom Farm House and Rowleaf "Wood, in West Wycombe aforesaid, and thence in a direction eastward of Booker "Hill and Homer's Farm Houses, through a part of the Parish of Chepping "Wycombe to Handy Cross, in the Parish of Great Marlow, and through a garden "or gardens belonging to Sir William Clayton, Bart., and now or late in the "several occupations of William Aris and John Midwinter;" and "the two lanes diverging therefrom to Cressicks, in the Parish of Chepping Wycombe, and "Red Barn, in the Parish of Great Marlow," ought not to become Main Roads.

its provisions, any road which has within the period between the Thirty-first day of December, One thousand eight hundred and seventy, and the date of the passing of that Act, ceased to be a turnpike road, and any road which, being at the time of the passing of that Act a turnpike road, may afterwards cease to be such, shall be deemed to be a Main Road;

And whereas it appeared to the County Authority for the County of Kent that the roads referred to in the first column of the Schedule hereto ought not to become Main Roads, and the said County Authority accordingly made application to the Local Government Board before the First day of February, One thousand eight hundred and seventy-nine, for a Provisional Order to declare that such roads ought not to become Main Roads;

And whereas the Local Government Board, being of opinion that there was probable cause for such application, caused the said roads to be inspected, and are satisfied that such roads ought not to become Main Roads:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the said Highways and Locomotives (Amendment) Act, 1878, do, by this Order, declare that the roads in the County of Kent which are referred to in the first column of the Schedule hereto ought not to become Main Roads.

And whereas by Section 16 of the same Act it is also enacted that if it appears to a County Authority that any road within their County which, within the period between the Thirty-first day of December, One thousand eight hundred and seventy, and the date of the passing of that Act, ceased to be a turnpike road, ought not to become a Main Road in pursuance of that Act, such Authority shall, before the First day of February, One thousand eight hundred and seventy-nine, make an application to the Local Government Board for a Provisional Order declaring that such road ought not to become a Main Road; and that the Local Government Board, if of opinion that there is probable cause for an application under that section, shall cause the road to be inspected and, if satisfied that it ought not to become a Main Road, shall make a Provisional Order accordingly;
