## CHAPTER clxii.

An Act to confirm a Provisional Order made by the Local Actovernment Board for Ireland under the Public Health (Ireland) Act 1878 relating to the Urban Sanitary District of Armagh. [7th August 1896.]

WHEREAS the Local Government Board for Ireland have made the Provisional Order set forth in the schedule hereto under the Public Health (Ireland) Act 1878:

And whereas it is requisite that the said Order should be c. 52. confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

1. The Order set out in the schedule hereto is hereby confirmed Order in schedule and all the provisions thereof shall have full validity and force.

# ARMAGH SEWERAGE WORKS.

#### PROVISIONAL ORDER.

9 Geo. IV.

WHEREAS the Town Commissioners of the Town of Armagh acting under the Lighting of Towns (Ireland) Act 1828 (herein-after called the sanitary authority) are the urban sanitary authority of the said town and are about to construct works for the sewerage and the disposal of the sewage of the said town and have presented a petition to the Local Government Board for Ireland (herein-after called the Local Government Board) in pursuance of the Public Health (Ireland) Act 1878 praying that they may be empowered to put in force the powers of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by agreement for the purposes of the said works:

And whereas the sanitary authority have deposited at the office of the Local Government Board in Dublin plans and a book of reference (hereinafter called the deposited plans and book of reference) showing the lands and premises proposed by the sanitary authority to be taken for the said purposes:

And whereas all advertisements and notices required by the Public Health (Ireland) Act 1878 having been previously published served and given the Local Government Board have caused a local inquiry to be held as to the propriety of assenting to the prayer of the said petition and it appears to the Local Government Board to be proper to assent thereto so far as the same relates to the lands and premises hereinafter particularly mentioned being a part only of the lands and premises comprised in the deposited plans and book of reference:

It is ordered by the Local Government Board as follows:—

Compulsory powers to take lands and premises.

1. After the confirmation of this Order by Parliament the sanitary authority shall be empowered to put in force the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement with reference to the lands and plots numbered in the said deposited plans and book of reference from number 1 to number 8 both inclusive situate in the county parish and barony of Armagh and in the townland of Corporation.

2. The sanitary authority shall not under the powers of this Order A.D. 1896, purchase or acquire ten or more houses which on the fifteenth day of December last were occupied either wholly or partly by persons belonging to the labouring class as tenants or lodgers or except with houses the consent of the Local Government Board ten or more houses which were not so occupied on the said fifteenth day of December last but class. have been or will be subsequently so occupied.

Armayk. Provision for occupied by labouring

For the purpose of this Order the expression "labouring class" means and includes mechanics artisans labourers and others working for wages hawkers costermongers persons not working for wages but working at some trade or handicraft without employing others except members of their own families and persons other than domestic servants whose income does not exceed an average of thirty shillings a week and the families of any such persons who may be residing with them.

-3. The power of taking lands otherwise than by agreement given by Duratica of this Order shall not be exercised after the expiration of three years Order. from the confirmation of this Order.

-4. All costs charges and expenses of and incidental to the application for Costs of Order. making obtaining and confirming this Order shall be paid by the sanitary authority as part of their expenses incurred in the execution of the Public Health (Ireland) Act 1878.

-5. This Order may be cited as the Armagh Sewerage Provisional Order Short title 1896.
