##### SUBSIDY AGREEMENTS WITH LOCAL AUTHORITIES

*(s. 79 of the Housing Finance Act 1972 and s. 59 of the Housing (Financial Provisions) (Scotland) Act 1972)*

1 In this Part “subsidy agreement” means an agreement made between a local authority and a housing association which provides for payments to be made under or by reference to any of the following enactments—

 section 29(1) of the <sup>M2</sup>Housing Act 1930,  
 section 27(3) of the <sup>M3</sup>Housing Act 1935,

 section 87(1) of the <sup>M6</sup>Housing (Scotland) Act 1950,

 section 2, 3 or 4 of the <sup>M8</sup>Housing and Town Development (Scotland) Act 1957,  
 section 1(2)(b) of the <sup>M9</sup>Housing (Financial Provisions) Act 1958,  
 section 1(2) of the <sup>M10</sup>Housing Act 1961,  
 section 2, 4, 5, 6 or 7 of the <sup>M11</sup>Housing (Scotland) Act 1962,  
 section 1(5) or 9(4) of the <sup>M12</sup>Housing Subsidies Act 1967,  
 section 2, 4, 6, 7, 9 or 10 of the <sup>M13</sup>Housing (Financial Provisions) (Scotland) Act 1968,

(being enactments with respect to which it was provided by the <sup>M14</sup>Housing Finance Act 1972 or the <sup>M15</sup>Housing (Financial Provisions) (Scotland) Act 1972 that no further payments were to be made for 1972-73 or any subsequent year).
