## LOCAL GOVERNMENT, SCOTLAND

The Local Government (Travelling Allowances, etc.) (Scotland)  
Amendment Regulations 1971

<i>Made</i> - - - -	22nd December 1971
<i>Laid before Parliament</i>	3rd January 1972
<i>Coming into Operation</i>	24th January 1972

In exercise of the powers conferred on me by sections 113 and 117 as read with section 118 of the Local Government Act 1948(a), and of all other powers enabling me in that behalf, I hereby make the following regulations:—

1. These regulations may be cited as the Local Government (Travelling Allowances, etc.) (Scotland) Amendment Regulations 1971 and shall come into operation on 24th January 1972.

2. The Interpretation Act 1889(b) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

3. In paragraph 3 of Schedule 1 to the Local Government (Travelling Allowances, etc.) (Scotland) Regulations 1970(c), for the sums of  $\frac{1}{2}$ d, 1d, 2 $\frac{1}{2}$ d, 3 $\frac{1}{2}$ d, 4d, 5 $\frac{1}{2}$ d, 11 $\frac{1}{2}$ d, 1s. 0 $\frac{1}{2}$ d, 1s. 2 $\frac{1}{2}$ d, 1s. 6d and 2s. 6d there shall be substituted the sums of 0·2p, 0·4p, 1·1p, 1·5p, 1·7p, 2·4p, 4·7p, 5·3p, 5·9p, 7·5p and 12·5p respectively.

4. In Schedule 2 to the said Regulations for the sums of 10s, 19s, 35s, 50s, 59s and 110s there shall be substituted the sums of £0·50, £0·95, £1·75, £2·50, £2·95 and £5·50 respectively.

5. After paragraph 2 of Schedule 2 to the said Regulations there shall be added—

“3. An amount payable by any body by way of subsistence allowance shall be reduced by an appropriate sum in respect of any meal provided for the claimant by that body, free of charge, during the period to which the allowance relates.”

## EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations decimalise the maximum rates of travelling and subsistence allowances provided for by the Local Government (Travelling Allowances, etc.) (Scotland) Regulations 1970. They also add to Schedule 2 of the 1970 Regulations a third paragraph in terms of which subsistence allowance is to be reduced in certain circumstances.
