## EXCHANGE CONTROL

The Exchange Control (Authorised Dealers and Depositaries)  
Order 1972

Made - - - - 3rd February 1972  
Coming into Operation 17th February 1972

The Treasury, in exercise of the powers conferred upon them by sections 36(5) and 42(1) of the Exchange Control Act 1947(a), hereby make the following Order:—

1.—(1) This Order may be cited as the Exchange Control (Authorised Dealers and Depositaries) Order 1972, and shall come into operation on 17th February 1972.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. Offices in the United Kingdom or the Channel Islands of the persons specified in Schedules 1 and 2 to this Order are authorised to act for the purposes of the said Act as authorised dealers in relation to gold.

3. Offices in the United Kingdom or the Channel Islands of the persons specified in Schedule 2 to this Order are authorised to act for the purposes of the said Act as authorised dealers in relation to all foreign currencies.

4. The following are authorised to act as authorised depositaries for the purposes of Part III of the said Act:—

- (a) the Bank of England, and the Quotations Department and the Official Assignee of the Stock Exchange, London;
- (b) offices in the United Kingdom or the Channel Islands of the persons specified in Schedule 2 to this Order;
- (c) the persons specified in Schedule 3 to this Order.

5. The Orders specified in Schedule 4 to this Order are hereby revoked.

6. This Order shall extend to the Channel Islands, and any reference in this Order to the Exchange Control Act 1947 includes a reference to that Act as extended by the Exchange Control (Channel Islands) Order 1947(c).
