**The Buckinghamshire County Council  
(Tinker's Footbridge, Milton Keynes) Scheme 1974  
Confirmation Instrument 1974**

*Made* - - - *26th September 1974*

The Secretary of State for the Environment makes this Instrument in exercise of powers conferred by section 3 of the Highways (Miscellaneous Provisions) Act 1961(a) and now vested in him (b) and of all other enabling powers:—

1. The Buckinghamshire County Council (Tinker's Footbridge, Milton Keynes) Scheme 1974 is hereby confirmed without modifications.

2. The said scheme as confirmed (hereinafter referred to as "the Scheme") is set out in the Schedule hereto and copies of the Scheme with its accompanying plans are deposited at the offices of the Department of the Environment, St. Christopher House, Southwark Street, London SE1 0TE and at the offices of the Buckinghamshire County Council at County Hall, Aylesbury, Bucks HP20 1UA.

3. The Scheme will become operative on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1959.

4. This Instrument may be cited as the Buckinghamshire County Council (Tinker's Footbridge, Milton Keynes) Scheme 1974 Confirmation Instrument 1974.

## THE SCHEDULE

### THE BUCKINGHAMSHIRE COUNTY COUNCIL (TINKER'S FOOTBRIDGE, MILTON KEYNES) SCHEME, 1974

THE COUNTY COUNCIL OF THE ADMINISTRATIVE COUNTY OF BUCKINGHAM (hereinafter referred to as "the Council") make this Scheme in exercise of their powers under section 3 of the Highways (Miscellaneous Provisions) Act, 1961, and of all other enabling powers:—

1. The Council are authorised to construct over the navigable waters of the British Waterways Board's canal at Tinker's Bridge, the footbridge specified in the Schedule to this Scheme as part of the highway plan for pedestrians in the designated area of Milton Keynes.
2. This Scheme may be cited as the Buckinghamshire County Council (Tinker's Footbridge, Milton Keynes) Scheme, 1974.

Given under the Common Seal of the Council the Twenty second day of February 1974.

#### THE SCHEDULE before referred to

The Scheme involves the construction of a steel footbridge of an overall length of 50 metres together with associated ramps and footways over the British Waterways Board canal at Tinker's Bridge (O.S. grid reference 87723677). The location and dimensions of the footbridge are shown on drawing no. CE/5014/16A attached hereto.
