The Buckinghamshire County Council (Startops End Canal Bridge) Scheme 1973 Confirmation Instrument 1974

Made 26th September 1974

The Secretary of State for the Environment makes this Instrument in exercise of powers conferred by section 3 of the Highways (Miscellaneous Provisions) Act 1961(a), and now vested in him (b), and of all other enabling powers:

- 1. The Buckinghamshire County Council (Startops End Canal Bridge) Scheme 1973 is hereby confirmed with modification.
- 2. The said Scheme as confirmed (hereinafter referred to as "the Scheme") is set out in the Schedule hereto and copies of the Scheme with its accompanying plans as modified, are deposited at the offices of the Department of the Environment, St. Christopher House, Southwark Street, London, SE1 OTE, and at the offices of the County Council of Buckinghamshire at County Hall, Avlesbury, Bucks HP20 1UA.
- 3. The Scheme will become operative on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1959(c).
- 4. This Instrument may be cited as the Buckinghamshire County Council (Startops End Canal Bridge) Scheme 1973 Confirmation Instrument 1974.

THE SCHEDULE

THE BUCKINGHAMSHIRE COUNTY COUNCIL (STARTOPS END CANAL BRIDGE) SCHEME, 1973

THE COUNTY COUNCIL OF THE ADMINISTRATIVE COUNTY OF BUCKINGHAM (hereinafter referred to as "the Council") make this Scheme in exercise of their powers under Section 3 of the Highways (Miscellaneous Provisions) Act, 1961, and of all other enabling powers:—

- The Council are authorised to construct over the navigable waters of the British Waterways Board's canal at Startops End, Marsworth, the bridge specified in the Schedule to this Scheme as part of the highway which they are proposing to improve between Aston Clinton and Ivinghoe in the said County.
- 2. This Scheme may be cited as the Buckinghamshire County Council (Startops End Canal Bridge) Scheme, 1973.

THE SCHEDULE before referred to

"The scheme involves the construction of a steel footbridge of 22.860 m span, together with associated steps and footways over the British Waterways Board canal at Startops End, Marsworth, (O.S. grid reference 920142) and is adjacent to the existing road bridge over the canal. Full details and dimensions of the footbridge are shown on drawing No. B489/46/7 attached hereto".

EXPLANATORY NOTE

(This Note is not part of the Confirmation Instrument.)

The scheme as published by Buckinghamshire County Council has been modified to include a span of 22.860m instead of 22.0m as shown on drawing No. B489/46/1. This modification will reduce the headroom but not below the minimum of 2.8m as shown on drawing No. B489/46/1.
