**WATER, ENGLAND AND WALES**

**The North West Water Authority (Macclesfield, Makerfield,  
West Cumberland, Lune Valley, Preston and District and  
North Calder) (Extension of Operation of Byelaws) Order 1976**

*Made - - - - -* 8th July 1976

*Coming into Operation* 1st August 1976

The Secretary of State for the Environment, in exercise of powers conferred by the proviso to section 19(6) of the Water Act 1945(a) and now vested in him(b), and of all other powers enabling him in that behalf, hereby orders as follows:—

1. This order may be cited as the North West Water Authority (Macclesfield, Makerfield, West Cumberland, Lune Valley, Preston and District and North Calder) (Extension of Operation of Byelaws) Order 1976 and shall come into operation on 1st August 1976.

2. In this order, unless the context otherwise require—  
“byelaws” means byelaws made under section 17 of the Water Act 1945;  
“the Order of 1975” means the North West Water Authority (Extension of Operation of Byelaws) Order 1975(c).

3. The byelaws made on 1st November 1963 by the Macclesfield District Water Board, which byelaws would, by virtue of the Order of 1975, remain in force until 31st October 1976, shall remain in force until 31st October 1978.

4. The byelaws made on 12th November 1963 by the Makerfield Water Board, which byelaws would, by virtue of the Order of 1975, remain in force until 11th November 1976, shall remain in force until 11th November 1978.

5. The byelaws made on 25th November 1963 by the West Cumberland Water Board, which byelaws would, by virtue of the Order of 1975, remain in force until 24th November 1976, shall remain in force until 24th November 1978.

6. The byelaws made on 13th December 1963 by the Lune Valley Water Board, which byelaws would, by virtue of the Order of 1975, remain in force until 12th December 1976, shall remain in force until 12th December 1978.

7. The byelaws made on 22nd September 1964 by the Preston and District Water Board, which byelaws would, by virtue of the North West Water Authority (Preston and District) (Extension of Operation of Byelaws) Order 1975(d), remain in force until 21st September 1976, shall remain in force until 21st September 1978.

8. The byelaws made on 26th October 1964 by the North Calder Water Board, which byelaws would, by virtue of the Order of 1975, remain in force until 25th October 1976, shall remain in force until 25th October 1978.
