PROBATION AND AFTER-CARE

The Combined Probation and After-Care Areas (Derbyshire) Order 1978

Made - - - - 2nd June 1978

Coming into operation in accordance with Article 1

In exercise of the powers conferred upon me by section 54(4) of, and paragraph 1 of Schedule 3 to, the Powers of Criminal Courts Act 1973(a) (as extended by Article 3 of the Combined Probation and After-Care Areas Order 1974(b)) and after the consultation required by that paragraph, I hereby make the following Order:—

1. This Order may be cited as the Combined Probation and After-Care Areas (Derbyshire) Order 1978 and shall come into operation on 1st July 1978, except that for the purpose of taking any decision under Article 3 below to have effect from 1st July 1978 this Order shall come into operation forthwith.

2. Schedule 2 to the Combined Probation and After-Care Areas Order 1974 shall be amended by substituting for the entry in respect of Derbyshire the following entry:—

3.—(1) The members of the Derbyshire Probation and After-Care Committee (hereafter referred to as "the Committee") appointed before 1st July 1978 by the justices for the petty sessional divisions of Ashbourne, Bakewell and Matlock shall continue to hold office, as if they had been appointed by the justices for the petty sessional division of West Derbyshire, until 30th November 1980 and shall then cease to hold office but shall be eligible for re-appointment.

(2) The members of the Committee appointed by the justices for the petty sessional divisions of Alfreton and Belper shall decide by agreement, or in default of agreement by lot, which two of their number shall continue to hold office after 30th June 1978, as if appointed by the justices for the petty sessional division of Alfreton and Belper, until 30th November 1980.

(3) The members of the Committee appointed by the justices for the petty sessional divisions of Derby, Derby County and Appletree and South Derbyshire shall decide by agreement, or in default of agreement by lot, which six of their number shall continue to hold office after 30th June 1978, as if appointed by the justices for the petty sessional division of Derby and South Derbyshire, until 30th November 1980.
