**The Anglian Water Authority (Abolition of the Cley and Wiveton
and the Salthouse and Kelling Internal Drainage Districts)
Order 1979**

Made - - - - 9th August 1979

Coming into Operation 26th September 1979

Whereas the the Anglian Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976(a) in relation to the Cley and Wiveton and the Salthouse and Kelling Internal Drainage Districts;

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of every other power enabling him in that behalf, hereby orders as follows:—

1. This Order, which may be cited as the Anglian Water Authority (Abolition of the Cley and Wiveton and the Salthouse and Kelling Internal Drainage Districts) Order 1979, shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Anglian Water Authority and shall be part of the administrative expenses of that Authority.

**LAND DRAINAGE ACT 1976
ANGLIAN WATER AUTHORITY**

**ABOLITION OF THE CLEY AND WIVETON AND THE SALTHOUSE AND KELLING
INTERNAL DRAINAGE DISTRICTS**

The Anglian Water Authority (hereinafter called "the Authority") have prepared the following Scheme under section 11(1) of the Land Drainage Act 1976, and submit it to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation under section 11(4) of the said Act of 1976.

SCHEME

On a day to be appointed by the Minister (which day is hereinafter referred to as "the appointed day") the following provisions shall have effect:

1. The Cley and Wiveton Internal Drainage District (constituted by the Scheme confirmed by the North Norfolk Rivers Catchment Board (Cley and Wiveton Internal Drainage District) Order 1932(a) as altered by the Scheme confirmed by the North Norfolk Rivers Catchment Board (Alteration of Boundaries of the Cley and Wiveton Internal Drainage District) Order 1950(b)) and the Salthouse and Kelling Internal Drainage District (constituted by the Scheme confirmed by the North Norfolk Rivers Catchment Board (Salthouse and Kelling Internal Drainage District) Order 1933(c)) and the respective drainage boards thereof (together hereinafter referred to as "the Drainage Boards") shall be abolished and the rights, powers, duties, obligations, liabilities and property (including in particular, but without prejudice to the generality of that expression, books of account, other books, deeds, maps, papers and other documents) of each of the Drainage Boards shall be transferred to the Authority.

2. The accounts of each of the Drainage Boards shall be made up to the appointed day and shall be audited in like manner and subject to the like incidents and consequences as if this Scheme had not been made: provided that any sum certified by the District Auditor at any such audit as due from any person shall be paid to the Authority.

3. Any monies transferred to the Authority being the balance of drainage rates levied by each of the Drainage Boards or any other assets so transferred shall be applied by the Authority as if the same were the proceeds of a general drainage charge levied by them under the provisions of section 48 of the Land Drainage Act 1976.

4. Any debts due from the Drainage Boards or either of them immediately before the appointed day shall be discharged by the Authority and any arrears of rates outstanding at the appointed day shall be paid to, and be recoverable by, the Authority.

5. As respects any matter transferred under this Scheme the Scheme shall operate as conclusive evidence of the transfer without the necessity of any further assignment or deed of transfer.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, made by the Minister of Agriculture, Fisheries and Food, confirms a Scheme submitted to him by the Anglian Water Authority for the abolition, on a day to be appointed by the Minister, of the Cley and Wiveton Internal Drainage District (constituted by the Scheme confirmed by the North Norfolk Rivers Catchment Board (Cley and Wiveton Internal Drainage District) Order 1932 (as altered) and the Salthouse and Kelling Internal Drainage District (constituted by the Scheme confirmed by the North Norfolk Rivers Catchment Board (Salthouse and Kelling Internal Drainage District) Order 1933) and the Drainage Boards thereof. On the appointed day all the rights and property of the Drainage Boards will be transferred to the Anglian Water Authority.
