# The Fettes College (Amendment) Scheme 1982

Made - - - - -

18th March 1982

Coming into Operation

18th March 1982

In exercise of the powers conferred on him by sections 105(1), 116 and 112(5) of the Education (Scotland) Act 1980(a) and all other powers enabling him in that behalf and after—

- (a) preparing a draft scheme to amend the Fettes College Scheme 1964,
- (b) carrying out the procedure specified in section 112(1) of the said Act,
- (c) receiving and considering objections or proposed amendments to the draft scheme,
- (d) framing a scheme under section 112(3) of the said Act to take account of the objections or proposed amendments received,
- (e) carrying out the procedure specified in section 112(4) of the said Act, and
- (f) no petition or appeal having been presented to the Court of Session and no petition having been presented to him,

the Secretary of State hereby makes the following scheme:—

### Citation

1. This scheme may be cited as the Fettes College (Amendment) Scheme 1982. The principal scheme and this scheme shall be construed as one and may be cited together as the Fettes College Schemes 1964 and 1982.

#### Interpretation

2. In this scheme, unless the context otherwise requires:—

"principal scheme" means the Fettes College Scheme 1964 as approved by Order in Council dated 14th May 1965(b).

## Amendment to Part I of the principal scheme:

3. The following section shall be substituted for section 2 of the principal scheme:

#### "Composition of body corporate

2.—(1) The composition of the body corporate (hereinafter referred to as "the Governors") shall be nine elected governors and not more than seven co-opted governors.

- (2) The following persons shall be the elected governors, that is to say:—
  - (a) one person to be elected by the Senators of Her Majesty's College of Justice:
  - (b) one person to be elected by Lothian Regional Council;
  - (c) one person to be elected by the University Court of the University of Edinburgh:
  - (d) one person to be elected by the Dean and Faculty of Advocates;
  - (e) one person to be elected by the Society of Writers to Her Majesty's Signet;
  - (f) one person to be elected by the Royal College of Physicians of Edinburgh;
  - (g) one person to be elected by the Master's Court of the Company of Merchants of the City of Edinburgh;
  - (h) one person to be elected by the Edinburgh Chamber of Commerce and Manufactures; and
  - (i) one person to be elected by the Old Fettesian Association from among former pupils of Fettes College.
- (3) The following persons shall be the co-opted governors, that is to say:—
  - (a) one person to be co-opted by the Governors from among ministers of religion; and
  - (b) not more than six persons of whom at least two shall be women to be co-opted by the Governors from among persons of experience which in the opinion of the Governors will be of value to the Governors in the exercise of their functions under this Scheme."

Amendment to Part III of the principal scheme

4. In section 26 (Income of the General Fund) the following amendment shall be made:—

in line 3 of subsection (1) the word "boys" where twice occurring shall be deleted and the word "pupils" shall be substituted therefor.

Amendments to Part IV of the principal scheme

5.—(1) In section 30 (Provision and development of Fettes College), the following amendment shall be made:—

in line 2, the words "for boys" shall be deleted.

(2) In section 36 (The curriculum) the following amendments shall be made:—

in subsections (1) and (2) the word "boys" shall, on each occasion it occurs, be deleted and the word "pupils" shall be substituted therefor.

- (3) In section 37 (Admission to and attendance at the College), the following amendments shall be made:—
  - (a) in subsection (1) the word "boys" shall, on each occasion it occurs, be deleted and the word "pupils" shall be substituted therefor.

- (b) subsection (2) shall be amended as follows:—
  - (i) in line 1, the word "boy" shall be deleted and the word "pupil" shall be substituted therefor;
  - (ii) in line 2, after the word "his", the words "or her" shall be inserted and after the word "he" the words "or she" shall be inserted;
  - (iii) in line 3, after the word "he" the words "or she" shall be inserted.
- (c) subsection (3) shall be amended as follows:—
  - (i) in lines 1, 2, 3, 5 and 10, the word "boy" shall, on each occasion it occurs, be deleted and the word "pupil" shall be substituted therefor;
  - (ii) in line 4 the word "boy's" shall be deleted and the word "pupil's" shall be substituted therefor.
- (4) In section 38 (Foundationers), the following amendment shall be made:—
  - (a) subsection (1) shall be amended as follows:—
    - (i) in line 1, after the word "son" the words "or daughter" shall be inserted:
    - (ii) in line 3, after the word "boy" the words "or girl" shall be inserted.
  - (b) in line 4 of subsection (3) after the word "boys" the words "or girls" shall be inserted.
  - (c) subsection (5) shall be amended as follows:—
    - (i) in line 3, after the word "his" the words "or her" shall be inserted:
    - (ii) in lines 5, 8 and 9 the words "or girl" shall be inserted after the word "boy", on each occasion it occurs;
    - (iii) in line 15, after the word "boys" the words "and girls" shall be inserted.
  - (d) subsection (7) shall be amended as follows:—
    - (i) in line 8 after the word "his" the words "or her" shall be inserted;
    - (ii) in line 9 after the word "he" the words "or she" shall be inserted;
    - (iii) in lines 10 and 13 the word "boy" shall, on each occasion it occurs, be deleted and the word "pupil" shall be substituted therefor.
- (5) In section 39 (Foundation Scholars), the following amendments shall be made:—
  - (a) in line 1 of subsection (1) after the word "boy" the words "or girl" shall be inserted;
  - (b) in line 5 of subsection (2), after the word "boys" the words "and girls" shall be inserted.

- (6) In section 40 (Fee-paying pupils), the following amendments shall be made to subsection (1):—
  - (a) in line 1, after the word "boy" the words "or girl" shall be inserted;
  - (b) in line 2, after the word "he" the words "or she" shall be inserted.
- (7) In section 41 (Transfers between groups), the following amendments shall be made:—
  - (a) subsection (1) shall be amended as follows:—
    - (i) in line 4, after the word "his" the words "or her" shall be inserted:
    - (ii) in line 6, the word "boy" shall be deleted and the word "pupil" shall be substituted therefor.
  - (b) subsection (3) shall be amended as follows:—
    - (i) in line 7 the word "boy" shall be deleted and the word "pupil" shall be substituted therefor;
    - (ii) in line 8 after the word "him" the words "or her" shall be inserted.

### Amendments to Part V of the principal scheme

6.—(1) In section 42 (Exhibitions and scholarships tenable at universities), the following amendment shall be made:—

in line 4 of subsection (4) after the word "him" the words "(or her, in the case of a Fettes Exhibition)" shall be inserted.

(2) In section 43 (Fettes College Scholarships tenable at the College), the following amendment shall be made:—

in line 3, after the word "boys" the words "and girls" shall be inserted.

- (3) In section 48 (Withdrawal of exhibitions, scholarships and bursaries), the following amendments shall be made:—
  - (a) in line 2, after the word "he" the words "or she" shall be inserted;
  - (b) in line 3 after the word "his" the words "or her" shall be inserted.

#### Amendment to Schedule 2 to the principal scheme

7. Schedule 2 shall be amended as follows:—

in column (6) of the entry relating to the Fettes Exhibitions, the word "boys" shall be deleted and the word "pupils" shall be substituted therefor.

### Copies of scheme

8. The Governors shall maintain a supply of printed copies of this scheme and shall cause a copy to be kept available for inspection by any governor or officer of the Governors and copies shall be made available for sale to the public at a reasonable price.
