**The Lothian Regional Council (Megget Reservoir etc.)
(Amendment) Water Order 1982**

<i>Made - - - -</i>	<i>26th March 1982</i>
<i>Coming into Operation</i>	<i>2nd April 1982</i>

The Secretary of State in exercise of the powers conferred on him by sections 17(2) and 107(1)(b) of the Water (Scotland) Act 1980(a) and of all other powers enabling him in that behalf, on the application of The Lothian Regional Council, hereby makes the following order:—

Citation and commencement

1.—(1) This order may be cited as The Lothian Regional Council (Megget Reservoir etc.) (Amendment) Water Order 1982 and shall come into operation on 2nd April 1982.

(2) This order and The South-East of Scotland Water Board (Megget Reservoir etc.) Water Order 1974(b) (hereinafter referred to as “the principal order”) shall be construed as one and may be cited together as The Lothian Regional Council (Megget Reservoir etc.) Water Orders 1974 and 1982.

Amendment of the principal order

2.—(1) In article 2 of the principal order to the definition of “deposited plans” there shall be added:—

“as modified and partially replaced, in relation to Sheets 3 and 4 thereof, by a plan, prepared in duplicate, sealed with the seal of the Secretary of State for Scotland and marked “The Lothian Regional Council (Megget Reservoir etc.) (Amendment) Water Order 1982 Works Nos. 6 & 8 Plan, Work No. 8 (part) Section” (hereinafter referred to as “the deposited amendment plan”) one copy of which is deposited in the office of the Scottish Development Department, New St Andrew’s House, Edinburgh and the other in the principal office of the Director of Administration of the Lothian Regional Council at Edinburgh.”

(2) In article 7(1)(c) of the principal order for the words “gauge ‘E’ incorporated in the fixed sill (part of Work No. 7) of” there shall be substituted the words “gauge or gauges incorporated in the control works (part of Work No. 8) of”

(3) In article 7(1)(d) of the principal order the words "through the existing outlet culvert and channel (part of Work No. 7) from the Loch" shall be deleted and for the words "gauge 'F' incorporated in the existing outlet (part of Work No. 7)" there shall be substituted the words "gauge or gauges (part of Work No. 8)"

(4) In article 7(2)(a) of the principal order the letter "D" shall be deleted.

(5) In article 7(2)(b) of the principal order the letter "D" shall be deleted and after the word "gauge" there shall be inserted the words "or gauges."

3. In Schedule 1 to the principal order Work No. 7 shall be deleted and for Work No. 8 there shall be substituted the following paragraph:—

"Control works and channels, river and loch shore protection works and ancillary works at the outlet of the Loch, the said control works incorporating approved gauges and a fish pass or ladder."

4. In section 2(a) of Schedule 2 to the principal order for the word "the" before "reservoir" there shall be inserted the word "a".

5. The Lothian Regional Council shall at all times after the expiration of six months from the date on which this order comes into operation keep at the principal office of the Director of Administration of the Council a copy thereof and one copy of the deposited amendment plan.
