The Surrey (District Boundaries) Order 1986

Made	25th February 1986
Laid before Parliament	3rd March 1986
Coming into Operation—	
for the purposes described in article 2(1)	31st March 1986
for all other purposes	1st April 1986

Whereas the Local Government Boundary Commission for England, acting pursuant to sections 47 and 51(1) of the Local Government Act 1972(a) has made proposals to the Secretary of State about alterations in the boundary between the borough of Guildford and the adjoining boroughs and district;

And whereas more than six weeks has elapsed since those proposals were made:

And whereas the Secretary of State has decided to give effect to the proposals with modifications:

Now, therefore, the Secretary of State, in exercise of his powers under sections 51(2) and 67(4) of that Act, and of all other powers enabling him in that behalf, hereby makes the following order:—

Title and commencement

- 1. This order may be cited as the Surrey (District Boundaries) Order 1986.
- 2.—(1) 31st March 1986 is hereby specified as the day on which this order shall come into operation for any purpose set out in regulation 4(1) (coming into operation of order) of the Local Government Area Changes Regulations 1976(b).
- (2) For all other purposes, this order shall come into operation on 1st April 1986.

Interpretation

3. In this order—

"the boundary maps" means the 24 maps issued by the Department of the Environment as the "Maps of the Surrey (District Boundaries) Order 1986":

"county electoral division" means an electoral division of the county of Surrey; and

"the 1976 Regulations" means the Local Government Area Changes Regulations mentioned in article 2(1).

Transfers between Guildford and Surrey Heath

- 4.—(1) The parts of the borough of Guildford and of the parish of Ash which are marked A22 and A23 on boundary maps 1 and 2 shall cease to form part of any parish, and shall be transferred to—
 - (a) the borough of Surrey Heath;
 - (b) the Mytchett ward of that borough; and
 - (c) the Frimley Green and Mytchett county electoral division.
- (2) The part of the borough of Guildford and of the parish of Pirbright which is marked A24 on boundary map 4 shall cease to form part of any parish, and shall be transferred to—
 - (a) the borough of Surrey Heath;
 - (b) the Frimley Green ward of that borough;
 - (c) the Frimley Green and Mytchett county electoral division; and
 - (d) the Farnham petty sessional division.
- (3) The part of the borough of Surrey Heath and of the unparished area of the former urban district of Frimley and Camberley which is marked A25 on boundary map 2 shall be transferred to—
 - (a) the borough of Guildford;
 - (b) the Ash Vale ward of that borough;
 - (c) the parish and county electoral division of Ash; and
 - (d) the North parish ward.

Transfers between Guildford and Woking

- 5.—(1) The parts of the borough of Guildford and of the parish of Pirbright which are marked A27 and A37 on boundary maps 5 and 7 shall cease to form part of any parish, and shall be transferred to—
 - (a) the borough of Woking;
 - (b) the Brookwood ward of that borough; and
 - (c) the Woking South-West county electoral division.

- (2) The part of the borough of Guildford and of the parish of Worplesdon which is marked A26 on boundary map 7 shall cease to form part of any parish, and shall be transferred to—
 - (a) the borough of Woking;
 - (b) the Brookwood ward of that borough;
 - (c) the Woking South-West county electoral division; and
 - (d) the Woking petty sessional division.
- (3) The parts of the borough of Woking and of the unparished area of the former urban district of Woking which are marked A28, A38 and A39 on boundary maps 6 and 7 shall be transferred to—
 - (a) the borough of Guildford;
 - (b) the Pirbright ward of that borough; and
 - (c) the Worplesdon county electoral division.

They shall become part of the parish of Pirbright.

Transfer from Guildford to Elmbridge

- 6. The part of the borough of Guildford and of the parish of Ockham which is marked A29 on boundary map 3 shall cease to form part of any parish, and shall be transferred to—
 - (a) the borough of Elmbridge;
 - (b) the Cobham and Downside ward of that borough;
 - (c) the Cobham and Oxshott county electoral division; and
 - (d) the Esher and Walton petty sessional division.

Transfers from Guildford to Mole Valley

- 7.—(1) The part of the borough of Guildford and of the parish of East Horsley which is marked A30 on boundary map 9 shall be transferred to—
 - (a) the district of Mole Valley;
 - (b) the Leith Hill ward of that district;
 - (c) the parish of Abinger;
 - (d) the North ward of that parish;
 - (e) the Dorking North county electoral division; and
 - (f) the Dorking petty sessional division.
- (2) The part of the borough of Guildford and of the parish of Effingham which is marked A31 on boundary map 11 shall cease to form part of any parish, and shall be transferred to—
 - (a) the district of Mole Valley;
 - (b) the Bookham South ward of that district;
 - (c) the Bookham and Fetcham West county electoral division; and
 - (d) the Dorking petty sessional division.

Transfers from Mole Valley to Guildford

- 8.—(1) The parts of the district of Mole Valley and of the unparished area of the former urban district of Leatherhead marked A32 and A33 on boundary maps 8 and 11 shall be transferred to—
 - (a) the borough of Guildford;
 - (b) the Effingham ward of that borough;
 - (c) the Horsleys county electoral division; and
 - (d) the Guildford petty sessional division.

They shall become part of the parish of Effingham, and the North ward of that parish.

(2) The parts of the district of Mole Valley and of the parish of Abinger marked A35 and A36 on boundary maps 9 and 10 shall be transferred to the borough of Guildford, and to the Guildford petty sessional division.

The part marked A35 shall be transferred to the parish of East Horsley, the Clandon and Horsley borough ward, and to the Horsleys county electoral division.

The part marked A36 shall be transferred to the parish and county electoral division of Shere, to the Shere South parish ward, and to the Tillingbourne borough ward.

Transfers from Guildford to Waverley

- 9. Each part of the borough of Guildford which is marked as indicated in column 1 of Schedule 1 hereto on the boundary map referred to in column 2 shall be transferred from the borough and from the parish mentioned to column 3 to—
 - (a) the borough of Waverley;
 - (b) the parish shown in column 4; and
 - (c) the parish ward, borough ward, county electoral division and petty sessional division (if any) shown in column 5.

Transfers from Waverley to Guildford

- 10. Each part of the borough of Waverley which is marked as indicated in column 1 of Schedule 2 hereto on the boundary map referred to in column 2 shall be transferred from the borough and from the parish described in column 3 to—
 - (a) the borough of Guildford;
 - (b) the parish named in column 4;
 - (c) the borough ward, parish ward and petty sessional division (if any) named in column 5; and
 - (d) the Shalford county electoral division.

Town and Country Planning

- 11.—(1) Any provisions of a local plan adopted by the Guildford borough council which apply immediately prior to 1st April 1986 to an area transferred by articles 4(1) and (2), 5(1) and (2), 6, 7 or 9 shall continue to have effect in relation thereto as if they were part of such a plan adopted by the council of the borough or district to which the area is transferred.
- (2) Any provisions of a local plan adopted by a borough or district which apply immediately prior to 1st April 1986 to an area transferred by articles 4(3), 5(3), 8 or 10 shall continue to have effect in relation thereto as if they were part of such a plan adopted by the Guildford borough council.

Statutory definitions of areas, etc.

- 12.—(1) For the purposes of regulation 40 (statutory definitions of areas) of the 1976 Regulations—
 - (a) any reference to the area of the former urban district of Frimley and Camberley shall be construed as including the areas mentioned in article 4(1) and (2) and excluding the part mentioned in article 4(3);
 - (b) any reference to the area of the former urban district of Woking shall be construed as including the areas mentioned in article 5(1) and (2), and excluding the parts mentioned in article 5(3);
 - (c) any reference to the area of the former urban district of Esher shall be construed as including the areas mentioned in article 6;
 - (d) any reference to the area of the former urban district of Leatherhead shall be construed as including the area mentioned in article 7(2), and excluding the parts mentioned in article 8(1).
- (2) Regulation 41 (Local Acts, orders and byelaws) of the 1976 Regulations shall apply to the area of each of the former urban districts named in paragraph (1) as if it were a relevant area within the meaning of regulation 41(2). For the purposes of any provision in force to which that regulation applies, each area shall be modified by the inclusions and exclusions mentioned in relation to it in sub-paragraphs (a) to (d) of that paragraph.

EXPLANATORY NOTE

(This note is not part of the order.)

This order transfers areas between the borough of Guildford and—

- (a) the borough of Surrey Heath;
- (b) the borough of Woking;
- (c) the borough of Elmbridge
- (d) the district of Mole Valley; and
- (e) the borough of Waverley.

Both parished and unparished areas are affected.

The map forming part of this note (page 9) gives a general guide to the areas affected by this order as from 1st April 1986.

Prints of the detailed boundary maps referred to in article 3 may be inspected at the offices of the borough and district councils, and may be inspected at or purchased from the Department of the Environment's Map Library, 2 Marsham Street, London SW1P 3EB.


The areas transferred between Guildford and Surrey Heath, Woking and Elmbridge each have a total area of under 2 hectares and a rateable value of approximately £1,000 or less. There are transfers of population from Guildford to Surrey Heath (20) and Woking (2).

The areas transferred between Guildford and Mole Valley have a total area of approximately 15 hectares and a population of 18. They have no rateable value.

The areas transferred between Guildford and Waverley have a total area of approximately 10 hectares, a population of 34 and a rateable value of £4,403.

Consequential changes to local government electoral areas are made.

The Local Government Area Changes Regulations 1976, mentioned in article 2(1), 3 and 12, contain further provisions about the effect and implementation of orders such as the present one.
