FORM OF CROSSINGS

Dimensions

7.—(1) Dimensions indicated on any diagram shown in the Schedules to these Regulations are expressed in millimetres.

(2) A dimension (other than one specified as a maximum or minimum dimension) specified in a diagram in Schedule 2 or 3 may be varied if, in the case of a dimension of the length specified in column (2) of an item in the table below, the variation does not exceed the extent specified in column (3) of the item.

Item	Length of dimension	Extent of variation
(1)	less than 10 mm	1 mm
(2)	10 mm or more but less than 50 mm	10 % of the dimension
(3)	50 mm or more but less than 300 mm	7.5% of the dimension
