**The GLA Side Roads (London Borough
of Wandsworth) Designation Order 2000**

Whereas the Secretary of State for the Environment, Transport and the Regions considers it appropriate for certain roads in the London borough of Wandsworth to be GLA side roads in the interests of the management of traffic and the control of the waiting and loading of vehicles on or in the immediate vicinity of GLA roads:

Now therefore the Secretary of State in exercise of the powers conferred by section 124A of the Road Traffic Regulation Act 1984(1) hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the GLA Side Roads (London Borough of Wandsworth) Designation Order 2000 and shall come into force on 19th June 2000.

Designation of GLA side roads

2.—(1) The roads in the London borough of Wandsworth specified in the Schedule to this Order are hereby designated as GLA side roads(2).

(2) The description of a road includes the intersection of that road and any other road that crosses it at the same level.

(3) In the Schedule “m” means metres.

(4) In accordance with section 124A(2) of the Road Traffic Regulation Act 1984, 3rd July 2000 is hereby specified as the date on which the designated roads are to become GLA side roads.

(1) 1984 c. 27; section 124A was inserted by section 272 of the Greater London Authority Act 1999 (c. 29).

(2) For the definition of GLA side road, see the Road Traffic Regulation Act 1984 sections 124A(9) and 142 (amended by the Greater London Authority Act 1999 section 292(3)).

 - (a) (north side) between its junction with Northcote Road and a point 18m west of the western kerbline of Northcote Road;
 - (b) (south side) between its junction with Northcote Road and a point 7m west of the western kerbline of Northcote Road.
2. Acris Street—
 - (a) (north east side) between its junction with Huguenot Place (A3) and a point 13m north west of the south eastern flank wall of 4 Huguenot Place;
 - (b) (south west side) between its junction with Huguenot Place (A3) and a point 4m north west of the north western flank wall of 2 Acris Street.
3. Alfriston Road between its junction with Clapham Common West Side (A3) and a point 14m north west of the north western boundary wall of 1 Alfriston Road.
4. All Saints Passage between its junction with Wandsworth High Street (A3) and a point 4m north of the northern kerbline of Wandsworth High Street.
5. Alma Road between its junction with East Hill (A3) and a point 20m north west of the north western kerbline of East Hill.
6. Almeric Road between its junction with Battersea Rise (A3) and a point 15m north of the northern boundary wall of 2 Almeric Road.
7. Altenburg Gardens—
 - (a) (east side) between its junction with Clapham Common North Side (A3) and a point 21m south of the southern boundary wall of 4 Altenburg Gardens;
 - (b) (west side) between its junction with Clapham Common North Side (A3) and a point 18m south of the southern boundary wall of 17 Altenburg Gardens.
8. Alton Road between its junction with Kingston Road (A3) and an imaginary straight line drawn between a point on the east side 18m north of the north western kerbline of Kingston Road and a point opposite.
9. Amerland Road between its junction with West Hill (A3) and the north western kerbline of Everatt Close.
10. Auckland Road between its junction with Battersea Rise (A3) and a point 5m north west of the north western boundary wall of 1 Auckland Road.
11. Barchard Street (north side) between its junction with Fairfield Street (A3) and a point 5m east of the eastern flank wall of 6 Barchard Street.
12. Bartholomew Close between its junction with East Hill (A3) and a point 2m south east of the north western flank wall of 50 East Hill.
13. Beaumont Road between its junction with West Hill (A3) and a point 4.5m north west of the front boundary of 173 and 175 Beaumont Road.
14. Bolingbroke Grove—

- (a) (north west side) between its junction with West Hill (A3) and the north eastern flank wall of 2 Merton Road;

- 55.** Muncaster Road between its junction with Clapham Common West Side (A3) and a point 10m north west of the north western boundary wall of 1 Muncaster Road.

- (a) (north west side) between a point 6.5m north east of the south western boundary of Chohole Gate Lodge and a point 22m south west of the south western flank wall of Chohole Gate Lodge;
- (b) (south east side) between a point 7.5 m north east of the south western boundary wall of Chohole Gate Lodge and a point 20m south west of the south western flank wall of Chohole Gate Lodge.
- 57.** Northcote Road between its junction with Battersea Rise (A3) and the north west flank wall of 11 Northcote Road.
- 58.** Portinscale Road between its junction with West Hill (A3) and the common boundary wall of 3 Portinscale Road and 102 West Hill.
- 59.** Putney Bridge Road—
- (a) (east side) between its junction with Wandsworth High Street (A3) and a point 14m north of the northern Boundary wall of 30 Putney Bridge Road;
- (b) (west side) between its junction with Wandsworth High Street (A3) and the southern kerbline of Chesterton Close.

60. Putney Heath Lane between its junction with West Hill (A3) and an imaginary straight line drawn between a point on the south west side 19m south west of the north western kerbline of West Hill and a point opposite.

61. Ringford Road between its junction with West Hill (A3) and a point 18m north west of the north western boundary wall of 1 Ringford Road.

62. Santos Road between its junction with West Hill (A3) and a point 24m south of the southern boundary wall of 1 Santos Road.

63. Sisters Avenue between its junction with Clapham Common North Side (A3) and a point 18.5m north of the northern kerbline of Clapham Common North Side.

64. Spanish Road—

(a) (north) between its junction with East Hill (A3) and a point 17m north of the northern boundary wall of 1 Spanish Road;

(b) (south)

(i) (south west side) between a point 15m south east of the south eastern flank wall of No. 5 Spanish Road and its junction with Wandsworth Common North Side,

(ii) (north east side) between a point 17m south east of the south eastern flank wall of No. 5 Spanish Road and its junction with Wandsworth Common North Side.

65. Spencer Park—

(a) (west arm) between its junction with Wandsworth Common North Side (A3) and an imaginary straight line drawn between a point on the east side at the front boundary of 51 and 53 Spencer park and a point opposite;

272. Latchmere Street between its junction with Battersea Park Road (A3205) and a point 22.5m south east of the south eastern kerblines of Battersea Park Road.

273. Lockington Road between its junction with York Road (A3205) and a point 20m south east of the south eastern kerblines of Battersea Park Road.

274. Lombard Road between its junction with York Road (A3205) and an imaginary straight line drawn between a point on the south west side 58m north west of the north western kerblines of York Road and a point opposite.

275. Macduff Road—

- (a) (north east side) between its junction with Battersea Park Road (A3205) and the south eastern flank wall of 2 Macduff Road;
- (b) (south west side) between its junction with Battersea Park Road (A3205) and a point 18m North west of the north western kerblines of Battersea Park Road.

276. Market Entrance between its junction with Nine Elms Lane (A3205) and the gates to Covent Garden Market.

277. Meath Street between its junction with Battersea Park Road (A3205) and a point 1m north west of the south eastern boundary of 1 Meath Street.

278. Mendip Road between its junction with York Road (A3205) and the south eastern flank wall of 2 to 24 Mendip Road.

279. Parkside Road—

- (a) (east side) between its junction with Battersea Park Road (A3205) and a point 20m south east of the south eastern kerblines of Battersea Park Road;

291. Usk Road between its junction with York Road (A3205) and a point 10m south east of the south eastern kerblines of York Road.

292. Winders Road—

(a) (west side) between its junction with Battersea Park Road (A3205) and the common boundary of 1 and 3 to 7 Winders Road;

(b) (east side) between its junction with Battersea Park Road (A3205) and a point 1m north of the common boundary of 1 and 3 to 7 Winders Road.

293. Wye Street between its junction with York Road (A3205) and a point 9m north west of the front boundary of 11 and 13 Wye Street.

315. Mysore Road—

- (a) (north side) between its junction with Elspeth Road (A3220) and a point 34m east of the north eastern kerbline of Elspeth Road;
- (b) (south side) between its junction with Elspeth Road (A3220) and the boundary wall of 84 Elspeth Road and 81 Mysore Road.

316. Parkgate Road—

- (a) (north west side) between its junction with Battersea Bridge Road (A3220) and the eastern boundary of 13 Parkgate Road;
- (b) (south east side) between its junction with Battersea Bridge Road (A3220) and a point 23m north east of the north eastern boundary of 59a Battersea Bridge Road.

317. Petworth Street between its junction with Battersea Bridge Road (A3220) and the common boundary of 2 and 3 Petworth Street.

318. Prince of Wales Drive between its junction with Albert Bridge Road (A3220) and the western kerbline of Soudan Road.

319. Rosenau Crescent—

- (a) between its junction with Prince of Wales Drive (A3220) and a point 10m south of the southern kerbline of Prince of Wales Drive;
- (b) between its junction with Battersea Bridge Road (A3220) and the common boundary of 14 and 16 Rosenau Crescent.

320. Rosenau Road between its junction with Prince of Wales Drive (A3220) and a point 10m north of the northern kerbline of Prince of Wales Drive.

321. Sabine Road between its junction with Latchmere Road (A3220) and the boundary wall of 131 Latchmere Road and 1 Eversleigh Road.

322. Sheepcote Lane between its junction with Latchmere Road (A3220) and a point 20m east of the north eastern kerbline of Latchmere Road.

323. Shellwood Road between its junction with Latchmere Road (A3220) and a point 2m north east of the south western boundary wall of 25 Poyntz Road.

324. Surrey Lane—

(a) (north side) between its junction with Battersea Bridge Road (A3220) and a point 21m west of the eastern kerbline of Battersea Bridge Road;

(b) (south side) between its junction with Battersea Bridge Road (A3220) and a point 25m west of the eastern kerbline of Battersea Bridge Road.

325. Westbridge Road between its junction with Battersea Bridge Road (A3220) and the common boundary of 10 and 12 Westbridge Road.

EXPLANATORY NOTE

(This note is not part of the Order)

Section 272 of the Greater London Authority Act 1999 inserts a new section 124A into the Road Traffic Regulation Act 1984 whereby the Secretary of State may designate roads or proposed roads which are to be GLA side roads, for which Transport for London will be the traffic authority. This Order designates the roads in the London Borough of Wandsworth specified in the Schedule as GLA side roads with effect from 3rd July 2000.
