- (3) Schedule 3 to the Civil Aviation Act 1949 (Overseas Territories) Order 1969(8) is amended by
 - (a) deleting, after the words "Falkland Islands", the words "(Colony and Dependencies)";
 - (b) inserting in the list of territories, in the appropriate alphabetical position, "South Georgia and the South Sandwich Islands"; and
 - (c) substituting for the words "St Helena and its Dependencies" the words "St Helena, Ascension and Tristan da Cunha".
- (4) The Schedule to the Air Navigation (Overseas Territories) (Environmental Standards) Order 2004(9) is amended by substituting for the words "St Helena" and "St Helena Dependencies (Tristan da Cunha and Ascension Island)" the words "St Helena, Ascension and Tristan da Cunha".
