The Legal Aid, Sentencing and Punishment of Offenders Act 2012 (Amendment of Schedule 1) (Advocacy Exceptions) Order 2014

Exceptions: advocacy in the Crown Court, magistrates' court and Upper Tribunal

2.—(1) Part 3 of Schedule 1 to the Legal Aid, Sentencing and Punishment of Offenders Act 2012 (advocacy: exclusion and exceptions) is amended as follows.

- (2) In paragraph 6 (proceedings in the Crown Court)—
 - (a) omit the "and" at the end of sub-paragraph (a);
 - (b) after sub-paragraph (a) insert—
 - "(aa) proceedings on an appeal under section 10(1)(b) of the Crime and Disorder Act 1998(1) against the making of a parenting order where an injunction is granted under section 1 of the Anti-social Behaviour, Crime and Policing Act 2014(2),"; and
 - (c) after sub-paragraph (b) insert—
 - "(c) proceedings on an appeal under section 46B of the Policing and Crime Act 2009(**3**), and
 - (d) proceedings on an appeal under section 15 of the Anti-social Behaviour, Crime and Policing Act 2014(4)."

(3) In paragraph 7 (proceedings in a magistrates' court)(5), in sub-paragraph (c) for "and 17(1) (a) and (b)" substitute ", 17 (1)(a) and (b), 36 and 38".

- (4) In paragraph 17 (proceedings in the Upper Tribunal)—
 - (a) omit the "or" at the end of sub-paragraph (a);
 - (b) at the end of sub-paragraph (b) insert ", or"; and
 - (c) after sub-paragraph (b) insert—
 - "(c) Part 3 of the Children and Families Act 2014(6) (children and young people in England with special educational needs or disabilities)."
