## TRANSPOSITION NOTE FOR THE IMPLEMENTATION OF THE OCCUPATIONAL ASPECTS OF THE BASIC SAFETY STANDARDS DIRECTIVE 2013/59/EURATOM (BSSD)

The Department for Business, Energy and Industrial Strategy (BEIS) has overall responsibility for UK transposition of the BSSD. A number of government departments are implementing regulations to transpose various aspects of the BSSD and each will complete a Transposition Note relating to the regulations they are implementing.

The Health and Safety Executive (HSE) is implementing the occupational aspects of the BSSD in The Ionising Radiations Regulations 2017 (IRR17). Some of these occupational aspects are already implemented by the Health and Safety at Work, etc. Act 1974 (HSWA) and the Management of Health and Safety at Work Regulations 1999 (MHSWR). Other occupational elements of the BSSD relate to the Requirements for the Approval of Dosimetry Services (RADS) and the Radiation Protection Adviser Statement of core competencies (RPA Statement) (both published by HSE).
