Designations under the Health Protection (Coronavirus, International Travel) (England) Regulations 2020

The Secretary of State makes the following designations, in relation to England, in exercise of the powers conferred by the Health Protection (Coronavirus, International Travel) (England) Regulations 2020¹ (as amended – "the Regulations") to take effect on the coming into force of the Health Protection (Coronavirus, International Travel) (England) (Amendment) (No. 7) Regulations 2021² at 04.00 on 15th February 2021:

Enforcing Quarantine/Isolation

1. In accordance with regulation 5(7) of the Regulations, the Secretary of State hereby designates as an "authorised person" for the purposes of regulations 5(1) and 5(1A) (Enforcement of requirement to self-isolate) the security personnel employed by the following companies and who are allocated to and performing duties under the contracts with the Secretary of State at the designated accommodation:

- (i) G4S Secure Solutions (UK) Limited,
- (ii) Mitie Limited, and
- (iii) Corps of Commissionaires Management Limited.

2. This designation does not include the use of reasonable force under regulation 5(3) in exercise of the powers in regulations 5(1) and 5(1A) for any of the authorised persons listed under paragraphs (i) to (iii) above.

Accommodation for and transportation to the managed self-isolation package

3. For the purposes of Schedule B1A and in accordance with paragraphs 15(a) and (b) therein of the Regulations, the Secretary of State designates for the purposes of the 'managed self-isolation package':

- (a) the following accommodation:
 - (i) Copthorne Gatwick,
 - (ii) Radisson Blu Edwardian Heathrow Hotel & Conference Centre,
 - (iii) Holiday Inn M4J4,
 - (iv) Novotel London Heathrow T1,2,3,
 - (v) Best Western London Ariel Hotel,
 - (vi) Renaissance London Heathrow,
 - (vii) Holiday Inn London Heathrow Bath Road,
 - (viii) Leonardo Hotel London Heathrow,
 - (ix) Courtyard by Marriott, Marylebone,
 - (x) Holiday Inn Express Birmingham NEC, and
- (b) transportation to the designated accommodation provided by CMAC Group UK Limited.

Permitting persons to leave or be outside place of self-isolation

4. For the purposes of paragraph 13(2) of Schedule B1 of the Regulations, the Secretary of State hereby designates as authorised persons who may permit a person to leave or be outside the place where they are self-isolating the security personnel employed by the following companies and who are allocated to and performing duties under the contracts with the Secretary of State:

- (i) G4S Secure Solutions (UK) Limited,
- (ii) Mitie Limited, and
- (iii) Corps of Commissionaires Management Limited.
- 5. These designations will have effect unless and until they are either amended or revoked.
