Mae'r Rheoliadau hyn yn diwygio'r diffiniad o "y Rheoliad", sef Rheoliad (EC) Rhif 1924/2006 Senedd Ewrop a'r Cyngor ar honiadau am faethiad ac iechyd a wneir ar fwydydd (OJ Rhif L12, 18.1.2007, t.3), a geir yn rheoliad 2 o'r Rheoliadau Honiadau am Faethiad ac Iechyd (Cymru) 2007 (O.S. 2007/2611). Effaith y diwygiad yw bod cyfeiriad at y Rheoliad yn O.S. 2007/2611 bellach yn cynnwys unrhyw ddiwygiadau a wneir yn y dyfodol i'w Atodiad, sy'n cynnwys y rhestr o honiadau a awdurdodir am faethiad ac amodau sy'n ymwneud â'u defnyddio (rheoliad 3).

These Regulations amend the definition of "the Regulation", meaning Regulation (EC) No. 1924/2006 of the European Parliament and of the Council on nutrition and health claims made on foods (OJ No. L12, 18.1.2007, p.3), contained in regulation 2 of the Nutrition and Health Claims (Wales) Regulations 2007 (S.I. 2007/2611). The effect of the amendment is that a reference to the Regulation in S.I. 2007/2611 now includes any future amendments to its Annex, which consists of the list of authorised nutrition claims and conditions relating to their use (regulation 3).

Mae Gweinidogion Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd gan adrannau 16(1)(e) ac (f), 17(2), 26(1)(a) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1), fel y'u darllenir ynghyd â pharagraff 1A o Atodlen 2 i Ddeddf y Cymunedau Ewropeaidd 1972(2).

Yn unol ag adran 48(4A) o Ddeddf Diogelwch Bwyd 1990, mae Gweinidogion Cymru wedi rhoi sylw i gyngor perthnasol a roddwyd iddynt gan yr Asiantaeth Safonau Bwyd.

Mae'r Rheoliadau hyn yn gwneud darpariaeth at ddiben a grybwyllir yn adran 2(2) o Ddeddf y Cymunedau Ewropeaidd 1972 ac mae'n ymddangos i Weinidogion Cymru ei bod yn hwylus dehongli cyfeiriadau at yr Atodiad i'r offeryn UE a grybwyllwyd yn rheoliad 3 fel cyfeiriadau at yr Atodiad hwnnw fel y caiff ei ddiwygio o bryd i'w gilydd.

**The Nutrition and Health Claims
(Wales) (Amendment) Regulations
2010**

Made 19 July 2010

Coming into force 1 October 2010

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(e) and (f), 17(2), 26(1)(a) and (3) and 48(1) of the Food Safety Act 1990(1), as read with paragraph 1A of Schedule 2 to the European Communities Act 1972(2).

In accordance with section 48(4A) of the Food Safety Act 1990, the Welsh Ministers have had regard to relevant advice given by the Food Standards Agency.

These Regulations make provision for a purpose mentioned in section 2(2) of the European Communities Act 1972 and it appears to the Welsh Ministers that it is expedient for references to the Annex to the EU instrument mentioned in regulation 3 to be construed as references to that Annex as it may be amended from time to time.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n pennu egwyddorion cyffredinol a gofynion cyfraith bwyd, ac yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn pennu gweithdrefnau o ran materion diogelwch bwyd(1), cafwyd ymgynghori agored a thryloyw â'r cyhoedd yn ystod cyfnod paratoi a gwerthuso'r Rheoliadau hyn.

1. Enw'r Rheoliadau hyn yw Rheoliadau Honiadau am Faethiad ac Iechyd (Cymru) (Diwygio) 2010 a deuant i rym ar 1 Hydref 2010.

Diwygio Rheoliadau Honiadau am Faethiad ac Iechyd (Cymru) 2007

2. Diwygir Rheoliadau Honiadau am Faethiad ac Iechyd (Cymru) 2007(2) yn unol â rheoliad 3.

3. Yn rheoliad 2(1) (dehongli) yn lle'r diffiniad o "y Rheoliad" rhodder y diffiniad a ganlyn—

"ystyr "y Rheoliad" ("*the Regulation*") yw Rheoliad (EC) Rhif 1924/2006 Senedd Ewrop a'r Cyngor ar honiadau am faethiad ac iechyd a wneir ar fwydydd gan gynnwys unrhyw ddiwygiadau i Atodiad y Rheoliad hwnnw a gaiff eu gwneud o bryd i'w gilydd(3)."

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(1), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

Title and commencement

1. The title of these Regulations is The Nutrition and Health Claims (Wales) (Amendment) Regulations 2010 and they come into force on 1 October 2010.

Amendment to the Nutrition and Health Claims (Wales) Regulations 2007

2. The Nutrition and Health Claims (Wales) Regulations 2007(2) are amended in accordance with regulation 3.

3. In regulation 2(1) (interpretation) for the definition of "the Regulation" substitute the following definition—

"the Regulation ("*y Rheoliad*") means Regulation (EC) No. 1924/2006 of the European Parliament and of the Council on nutrition and health claims made on foods including any amendments to the Annex to that Regulation as may be made from time to time(3)."
