Yn y Rheoliadau hyn, mae Gweinidogion Cymru yn gwneud darpariaeth ynghylch cynnwys y rhestr o bersonau sydd wedi eu tynnu oddi ar y gofrestr a chyhoeddi’r rhestr, neu wybodaeth benodedig o’r rhestr, yn unol ag adran 110(6) o’r Ddeddf.

**SOCIAL CARE, WALES**

The Social Care Wales (List of Persons Removed from the Register) Regulations 2016

**EXPLANATORY NOTE**

(*This note is not part of the Regulations*)

Under section 80(1) of the Regulation and Inspection of Social Care (Wales) Act 2016 (“the Act”), Social Care Wales (“SCW”) must keep a register of social workers, certain social care workers and visiting social workers from relevant European States. Section 110(1) of the Act provides that SCW must also keep a list of persons whose entries in the register have been removed in the circumstances specified in section 110(2) and (4) of the Act.

In these Regulations, the Welsh Ministers make provision about the content of the list of persons removed from the register and the publication of the list, or specified information from the list, pursuant to section 110(6) of the Act.

The Welsh Ministers’ Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to these Regulations. As a result, a regulatory impact assessment has been prepared as to the likely costs and benefits of complying with these Regulations. The Social Care Wales (List of Persons Removed from the Register) Regulations 2016

*Made* 15 November 2016

*Laid before the National Assembly for Wales* 22 November 2016

*Coming into force* 3 April 2017

The Welsh Ministers in exercise of the powers conferred upon them by sections 110(6) and 187(1)(b) of the Regulation and Inspection of Social Care (Wales) Act 2016(1) make the following Regulations.

**Title, commencement and application**

1.—(1) The title of these Regulations is the Social Care Wales (List of Persons Removed from the Register) Regulations 2016.

(2) These Regulations come into force on 3 April 2017.

(3) These Regulations apply in relation to Wales.

**Interpretation**

2. In these Regulations—

“the Act” (“*y Ddeddf*”) means the Regulation and Inspection of Social Care (Wales) Act 2016;

“SCW” (“GCC”) means Social Care Wales(2).

(2) The Care Council for Wales was renamed Social Care Wales by section 67(3) of the Act.

## Cynnwys y rhestr

3. Rhaid i gofnod ar y rhestr o bersonau sydd wedi eu tynnu oddi ar y gofrestr y mae rhaid i GCC ei chadw o dan adrann 110(1) o'r Ddeddf ddangos mewn cysylltiad â phob person—

- (a) enw'r person,
- (b) y dyddiad y cafodd y person ei dynnu oddi ar y gofrestr, ac
- (c) pa un neu ba rai o'r amgylchiadau yn adrann 110(2) neu (4) o'r Ddeddf a berodd i'w gofnod yn y gofrestr gael ei ddileu.

## Cyhoeddi

4.—(1) Rhaid i GCC gyhoeddi ar ei wefan restr gyfredol o'r personau sydd wedi eu tynnu oddi ar y gofrestr, y mae rhaid iddi gynnwys yr wybodaeth a bennir ym mharagraffau (a) i (c) o reoliad 3.

(2) Rhaid i GCC gydymffurfio ag unrhyw gais rhesymol a wneir gan berson i gael copi o'r rhestr neu wybodaeth benodedig o'r rhestr.

## Content of the list

3. An entry on the list of persons removed from the register which must be kept by SCW under section 110(1) of the Act must show in respect of each person—

- (a) the name of the person,
- (b) the date on which the person was removed from the register, and
- (c) which of the circumstances in section 110(2) or (4) of the Act caused their entry in the register to be removed.

## Publication

4.—(1) SCW must publish on its website an up-to-date list of persons removed from the register, which must include the information specified at paragraphs (a) to (c) of regulation 3.

(2) SCW must comply with any reasonable request made by a person for a copy of, or specified information from, the list.
