GENERAL PROVISIONS RELATING TO LICENCES UNDER PARTS II AND III

35^{F1} False statements.

^{F2} A person who for the purpose of—

- (a) obtaining the grant of a licence under Part II^{F3} ... to himself or any other person;
- (b) preventing the grant of any such licence; or
- (c) procuring the attachment of conditions to, or the amendment of conditions attached to, any such licence; [^{F4} or

knowingly makes a statement which is false in a material particular shall (without prejudice to [^{F9} Article 10 of the Perjury (Northern Ireland) Order 1979]) be guilty of an offence and shall be liable on summary conviction to a fine not exceeding [^{F10} level 3 on the standard scale] or to imprisonment for a term not exceeding six months, or to both such fine and such imprisonment.
