#### *[<sup>F1</sup>Advisory Council on Messengers-at-Arms and Sheriff Officers]*

#### 51 [<sup>F1</sup>Advisory Council's] annual report

- <sup>F2</sup>(1) .....
- (2) [<sup>F3</sup>The Advisory Council on Messengers-at-Arms and Sheriff Officers (the “Advisory Council”)] must prepare a report on its activities during the whole of each financial year as soon as practicable after the end of the period to which the report relates.
- (3) A report prepared under subsection (2) above—
- <sup>F4</sup>(a) .....
- (b) may include a statistical analysis of the performance by [<sup>F5</sup>officers of court] of their functions and the undertaking by officers of activities during the period to which the report relates or any other period specified by the [<sup>F6</sup>Advisory Council] in the report.
- (4) The [<sup>F7</sup>Advisory Council] may, in preparing the report under subsection (2) above, require [<sup>F8</sup>the professional association designated by regulations under section 63(1)(a)] to provide any information [<sup>F9</sup>provided by virtue of regulations under section 63(1A) which the Advisory Council] considers necessary or proper for the purposes of preparing the report.
- (5) The [<sup>F10</sup>Advisory Council] must—
- (a) send a copy of each report prepared under subsection (2) above to the Scottish Ministers; and
- (b) publish the report.
