### Whereas:

- (1) The table for product family 'FLOORINGS (2/2)' in Annex III of Commission Decision 97/808/EC of 20 November 1997 on the procedure for attesting the conformity of construction products pursuant to Article 20(2) of Council Directive 89/106/EEC as regards floorings<sup>(2)</sup> wrongly attributes attestation of conformity system 3 to class F<sub>FL</sub>.
- (2) Decision 97/808/EC should therefore be amended accordingly.
- (3) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on Construction,

# HAS ADOPTED THIS DECISION:

Article 1

Annex III to Decision 97/808/EC is amended as set out in the Annex to this Decision.
