CHAPTER V

IMPLEMENTING POWERS AND COMMITTEE PROCEDURE

Article 30

Amendment of the Annexes and implementing rules

1 [F¹The appropriate authority may, by regulations, amend the Annexes to the Regulation], with a view in particular to their adaptation to technological and scientific progress^{F2}....

2 [F³The appropriate authority may, by regulations, provide any] detailed rules necessary for the implementation of this Regulation^{F4}....

3 Certificates or other documents provided for by the [F⁵retained EU] veterinary legislation for live animals may be supplemented [F⁶by the appropriate authority, by regulations,] in order to take into account of the requirements of this Regulation.

4 [F⁷The appropriate authority may, by regulations, extend the obligation] to hold a certificate of competence as provided for in Article 6(5)^{F8}... to drivers or attendants of other domestic species^{F9}....

5 Derogations from paragraph 2(e) of Chapter I of Annex I may be adopted by [F¹⁰the appropriate authority, through regulations,] in case of exceptional market support measures due to movement restrictions under veterinary disease control measures.^{F11}...

6 Derogations concerning requirements for long journeys to take account of the remoteness of certain regions from the mainland of [F¹²Great Britain], may be adopted [F¹³by the appropriate authority, through regulations].

1 Regulations made by the Secretary of State or the Welsh Ministers under this Regulation are to be made by statutory instrument.

2 For regulations made under this Regulation by the Scottish Ministers, see section 27 of the Interpretation and Legislative Reform (Scotland) Act 2010.

4 A statutory instrument containing regulations made by the Secretary of State under this Regulation is subject to annulment in pursuance of a resolution of either House of Parliament.

5 A statutory instrument containing regulations made by the Welsh Ministers under this Regulation is subject to annulment in pursuance of a resolution of the National Assembly for Wales.

6 Regulations made by the Scottish Ministers under this Regulation are subject to the negative procedure (see section 28 of the Interpretation and Legislative Reform (Scotland) Act 2010).
