SENTENCE

Introductory

Penalty points: modification where fixed penalty also in question

- 32.**—(1) Articles 30 and 31 shall have effect subject to this Article in any case where—
- (a) a person is convicted of an offence involving obligatory endorsement, and
 - (b) the court is satisfied that the counterpart of his licence [^{F1}or his driving record] has been or is liable to be endorsed under Article 63 [^{F2}, 63A, 82 or 82A] in respect of an offence (referred to in this Article as the “connected offence”) committed on the same occasion as the offence of which he is convicted.
- (2) The number of penalty points to be attributed to the offence of which he is convicted is—
- (a) the number of penalty points to be attributed to that offence under Article 30 apart from this Article, less
 - (b) the number of penalty points required to be endorsed on the counterpart of his licence [^{F3}or on his driving record] under Article 63 [^{F4}, 63A, 82 or 82A] in respect of the connected offence (except so far as they have already been deducted by virtue of this sub-paragraph).
