 - (c) tattooing;
 - (d) tanning;
 - (e) services in spas;
 - (f) sports and massage therapy;
 - (g) well-being and holistic therapies;
 - (h) dress fitting, tailoring and fashion design ^{F12}...;
 - (i) body piercing;
 - (j) electrolysis;
 - (k) training in any of the services listed at (a) to (j) ^{F12}...;
 - (l) driving instruction for the test of competence to drive a vehicle other than a motorcycle established by Article 5 of the Road Traffic (Northern Ireland) Order 1981 ^{M1}.
