## The Social Security (Habitual Residence and Past Presence) (Amendment) Regulations (Northern Ireland) 2022

## Amendment of disability and carers benefit legislation

- **4.**—(1) The provisions specified in paragraph (4) are amended in accordance with paragraphs (2) and (3).
  - (2) In paragraph (1)—
    - (a) at the end of sub-paragraph (d)(1) omit "or";
    - (b) after sub-paragraph (e) add—
      "or
      - (f) leave to enter or remain in the United Kingdom granted under or outside the immigration rules or a right of abode in the United Kingdom within the meaning given in section 2 of the Immigration Act 1971 where the person—
        - (i) was residing in Ukraine immediately before 1st January 2022; and
        - (ii) left Ukraine in connection with the Russian invasion which took place on 24th February 2022.".
- (3) In paragraph (1A)(2) for "paragraph (1)(c), (d) or (e)" substitute "any sub-paragraph in paragraph (1)".
  - (4) The provisions referred to in paragraph (1) are—
    - (a) regulation 9C of the Social Security (Invalid Care Allowance) Regulations (Northern Ireland) 1976(3) (refugees and certain persons with leave to enter or remain in the United Kingdom(4));
    - (b) regulation 2C of the Social Security (Attendance Allowance) Regulations (Northern Ireland) 1992(5) (refugees and certain persons with leave to enter or remain in the United Kingdom);
    - (c) regulation 2C of the Social Security (Disability Living Allowance) Regulations (Northern Ireland) 1992(6) (refugees and certain persons with leave to enter or remain in the United Kingdom).
