The Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2022

Made - - - - 18th February 2022
Coming into operation 15th March 2022

The Department of Finance(1) makes the following Regulations in exercise of the powers conferred by Article 31C of the Rates (Northern Ireland) Order 1977(2).

Citation and commencement

1. These Regulations may be cited as the Rates (Small Business Hereditament Relief) (Amendment) Regulations (Northern Ireland) 2022 and shall come into operation on 15th March 2022.

Definition of "qualifying year"

2. In the definition of "qualifying year" in regulation 2 of the Rates (Small Business Hereditament Relief) Regulations (Northern Ireland) 2010(3) for the words "1st April 2022" there shall be substituted the words "1st April 2023".
