**The Welfare Reform and Pensions Act 1999  
(Scotland) (Commencement No. 8) Order 2000**

*Made - - - - 30th June 2000*

The Scottish Ministers, in exercise of the powers conferred upon them by section 89(1) of the Welfare Reform and Pensions Act 1999<sup>(1)</sup>, hereby make the following Order:

**Citation, interpretation and extent**

1. This Order may be cited as the Welfare Reform and Pensions Act 1999 (Scotland) (Commencement No. 8) Order 2000.

(2) In this Order, “Act” means the Welfare Reform and Pensions Act 1999.

(3) This Order extends to Scotland only.

**Appointed day**

2. The day appointed for the coming into force of—

(a) section 84(1) of the Act so far as relating to paragraph 10 of Schedule 12 to the Act; and

(b) paragraph 10 of Schedule 12 to the Act,

is 1st December 2000.
