**The Fife National Health Service  
Trusts (Dissolution) Order 2003**

*Made* - - - - - *19th September 2003*

*Coming into force* - - - - - *1st October 2003*

The Scottish Ministers, in exercise of the powers conferred by sections 12A(1) and 105(6) of and paragraph 25(1) of Schedule 7A to the National Health Service (Scotland) Act 1978<sup>(1)</sup> and of all other powers enabling them in that behalf, having received an application<sup>(2)</sup> from each of the National Health Service trusts specified in Schedule 1 to this Order, and after completion of the consultation prescribed<sup>(3)</sup> under paragraph 25(3) of the said Schedule 7A, hereby make the following Order:

**Citation and commencement**

1. This Order may be cited as the Fife National Health Service Trusts (Dissolution) Order 2003 and shall come into force on 1st October 2003.

**Dissolution of NHS trusts**

2. The National Health Service trusts specified in Schedule 1 to this Order are hereby dissolved.

**Revocations**

3. The Orders specified in Schedule 2 to this Order are hereby revoked.

### EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order provides by article 2 for the dissolution on 1st October 2003 of the two National Health Service trusts detailed in Schedule 1.
