The Lands Tribunal for Scotland Amendment (Fees) Rules 2003

The Scottish Ministers, in exercise of the powers conferred by section 3(6) and (12)(e) of the Lands Tribunal Act 1949(1) and of all other powers enabling them in that behalf, and after consultation with the Scottish Committee of the Council on Tribunals in accordance with section 8(1) of the Tribunals and Inquiries Act 1992(2), hereby make the following Rules:

Citation and commencement

1. These Rules may be cited as the Lands Tribunal for Scotland Amendment (Fees) Rules 2003 and shall come into force on 1st November 2003.

Table of Fees

2. The Table of Fees set out in the Schedule to these Rules shall be inserted after the Table of Fees contained in Schedule 2 to the Lands Tribunal for Scotland Rules 1971(3).

- **16.** On an application under section 20 of the £150 Abolition of Feudal Tenure etc. (Scotland) Act 2000(4)
- 17. On an application under section 90(1) £150 (b)(ii) of the Title Conditions (Scotland) Act 2003(5)
- **18.** On an application under the Land Reform £150 (Scotland) Act 2003(6)
- **19.** On a referral under section 86(5) of £150 the Title Conditions (Scotland) Act 2003 or section 44 of the Abolition of Feudal Tenure etc. (Scotland) Act 2000
- **20.** On the hearing of an application or £155 for each day on which the Tribunal sits referral under items 16, 17, 18 or 19 above
- **21.** On the making of an order under £88 + 100 per cent of the cost of registering the section 20 of the Abolition of Feudal Tenure order where the Tribunal is obliged to do so etc. (Scotland) Act 2000, the Land Reform (Scotland) Act 2003 or under section 90(1)(b)(ii) of the Title Conditions (Scotland) Act 2003
- **22.** For placing an advertisement in 100 per cent of the cost of the advertisement in connection with applications under section 20 of an appropriate newspaper (charge is restricted the Abolition of Feudal Tenure etc. (Scotland) to the cost of one advertisement irrespective of Act 2000 and section 90(1)(b)(ii) of the Title the number of advertisements placed) Conditions (Scotland) Act 2003
