**PUBLIC BODIES**

The Public Appointments and Public Bodies etc.  
(Scotland) Act 2003 (Commencement No. 3) Order 2004

Made - - - - 20th May 2004

The Scottish Ministers, in exercise of the powers conferred by section 21(2) and (3) of the Public Appointments and Public Bodies etc. (Scotland) Act 2003<sup>(1)</sup>, hereby make the following Order:

**Citation**

1. This Order may be cited as the Public Appointments and Public Bodies etc. (Scotland) Act 2003 (Commencement No. 3) Order 2004.

**Commencement**

2. The day appointed for the coming into force of—
- (a) sections 1, 2 and 3; and
  - (b) schedules 1 and 2

of the Public Appointments and Public Bodies etc. (Scotland) Act 2003 is 1st June 2004.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

The Public Appointments and Public Bodies etc. (Scotland) Act 2003 (“the Act”) received Royal Assent on 11th March 2003.

This Order brings into force the provisions of sections 1, 2 and 3 to the Act which provides for the establishment of the Office of Commissioner for Public Appointments in Scotland and outlines the Commissioner’s functions.

This Order also brings into force schedules 1 and 2 to the Act.

Schedule 1 makes further provision about the appointment and status of the Commissioner and details certain administrative matters relating to the Office of the Commissioner.

Schedule 2 lists those public bodies that are subject to the code of practice for public appointments prepared by the Commissioner.
