**TOWN AND COUNTRY PLANNING**

The Planning etc. (Scotland) Act 2006  
(Commencement No. 9) Order 2009

Made - - - - 3rd June 2009

The Scottish Ministers make the following Order in exercise of the powers conferred by section 59(2) of the Planning etc. (Scotland) Act 2006<sup>(1)</sup>.

**Citation and interpretation**

1.—(1) This Order may be cited as the Planning etc. (Scotland) Act 2006 (Commencement No. 9) Order 2009.

(2) In this Order—

“the 1997 Act” means the Town and Country Planning (Scotland) Act 1997<sup>(2)</sup>;

“the Act” means the Planning etc. (Scotland) Act 2006; and

“the Schedule” means the Schedule to this Order.

**Commencement**

2.—(1) Subject to paragraph (2) the provisions of the Act specified in column 1 of the Schedule (and the subject matter of which is described in column 2 of the Schedule), to the extent not already in force, come into force on 3rd August 2009 for all purposes.

(2) Where a purpose is specified in column 3 of the Schedule in relation to any provision, that provision shall, to the extent not already in force, come into force on 3rd August 2009 only for that purpose.

Article 2(2) limits the purposes for which the Schedule to the Act is commenced on 3rd August 2009.
