**The Lands Tribunal for Scotland Amendment (Fees) Rules 2014**

*Made* - - - - 23rd January 2014  
*Laid before the Scottish*

*Coming into force* - - 6th March 2014

The Scottish Ministers make the following Rules, in exercise of the powers conferred by sections 3(6) and (12)(e) of the Lands Tribunal Act 1949(1) and all other powers enabling them to do so.

**Citation and commencement**

1. These Rules may be cited as the Lands Tribunal for Scotland Amendment (Fees) Rules 2014 and come into force on 6th March 2014.

2. At the end of the Table of Fees contained in Schedule 2 to the Lands Tribunal for Scotland Rules 1971(2) insert the fees set out in the table in the Schedule to these Rules.

For placing an advertisement in connection with applications under section 22 or 69 of the Long Leases (Scotland) Act 2012	100 per cent of the cost of the advertisement in an appropriate newspaper (charge is restricted to the cost of one advertisement irrespective of the number of advertisements placed)
