The Foods for Specific Groups (Medical Foods)
(Miscellaneous Amendments) (Scotland) Regulations 2018

Made - - - 19th December 2018

Laid before the Scottish

Parliament - - - 20th December 2018

Coming into force - - 22nd February 2019

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 16(1), 17(1) and (2), 26(1) and (3) and 48(1) of the Food Safety Act 1990 MI and all other powers enabling them to do so.

In accordance with section 48(4A) of that Act ^{M2}, before making these Regulations the Scottish Ministers have had regard to any relevant advice given by Food Standards Scotland.

There has been consultation as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety M³.

In so far as not so transferred, and in so far as relating to food (including drink) including the primary production of food, those functions were transferred to the Scottish Ministers by the Scotland Act 1998 (Transfer of Functions to the Scottish ministers etc.) Order 2005 (S.I. 2005/849).

Citation, commencement and extent S

- 1.—(1) These Regulations may be cited as the Foods for Specific Groups (Medical Foods) (Miscellaneous Amendments) (Scotland) Regulations 2018 and come into force on 22 February 2019
 - (2) These Regulations extend to Scotland only.

 - (a) at the end of paragraph (e) insert " and ",
 - (b) in paragraph (f), for "regulation 2(1)(a)" substitute "regulation 2(1)",
 - (c) at the end of paragraph (f) omit "and", and
 - (d) omit paragraph (g).
 - (4) In schedule 1 (essential composition of relevant food)—
 - (a) in each of paragraphs 1.1, 2.1, 3.2, 4 and 5.1, for "regulation 2(1)(a)" substitute "regulation 2(1)",
 - (b) in paragraph 2.1 omit "and (b)", and
 - (c) omit paragraphs 1.2, 3.3 and 5.2.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations make provision to enforce, in Scotland, Commission Delegated Regulation (EU) 2016/128 supplementing Regulation (EU) 609/2013 of the European Parliament and of the Council as regards the specific compositional and information requirements for food for special medical purposes.

Regulation 3 restricts the application of the Foods for Special Medical Purposes (Scotland) Regulations 2000 to food for medical purposes developed to satisfy the needs of infants and, in relation to food that is labelled or placed on the market before 22 February 2019.

Regulation 4 amends the Foods for Specific Groups (Scotland) Regulations 2016 which enforce the provisions of Regulation (EU) 609/2013 of the European Parliament and of the Council on the provisions of food intended for infants and young children, food for special medical purposes and total diet replacement for weight control.

In addition, regulation 2 amends the Foods Intended for Use in Energy Restricted Diets for Weight Reduction Regulations 1997, to remove redundant text in respect of labelling requirements. A full business and regulatory impact assessment of the effect these Regulations will have on the costs for the business sector has been prepared and placed in the Scottish Parliament Information Centre.
