The Bankruptcy (Miscellaneous  
Amendments) (Scotland) Regulations 2021

*Made* - - - - *16th March 2021*

*Coming into force* - - *29th March 2021*

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 2(2)(b)(ii), 2(5), 9(4), 16(1)(i), 19(1), 46(2)(a), 87(8), 94(7)(a), 113(5), 116(2), 119(6)(a), 137(2), 140(2), 141(2)(a) and (c), 142(2) and (5), 205(1), 224, 225(2) and 227 of the Bankruptcy (Scotland) Act 2016<sup>(1)</sup>, section 10 of the Coronavirus (Scotland) (No. 2) Act 2020<sup>(2)</sup>, and all other powers enabling them to do so.

In accordance with section 225(4)(a) of the Bankruptcy (Scotland) Act 2016, a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament<sup>(3)</sup>.
