# The Social Security (Up-rating) (Miscellaneous Amendments) (Scotland) Regulations 2024

#### Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Social Security (Up-rating) (Miscellaneous Amendments) (Scotland) Regulations 2024.
  - (2) Subject to paragraphs (3) and (4), these Regulations come into force on 1 April 2024.
  - (3) Regulation 7 comes into force on 7 April 2024.
  - (4) Regulations 2, 3 and 8 come into force on 8 April 2024.
  - (5) In these Regulations—
    - "the Adult Disability Payment Regulations" means the Disability Assistance for Working Age People (Scotland) Regulations 2022(1),

### Amendment of the Adult Disability Payment Regulations

- (3) In paragraph 4 (value of grant) of schedule 3 (early learning grant)(18), for "£294.70" substitute "£314.45".
- (4) In paragraph 5 (value of grant) of schedule 4 (school-age grant)(19), for "£294.70" substitute "£314.45".

#### **Amendment of the Carer's Allowance Regulations**

**6.** In regulation 8(1) (circumstances in which a person is or is not to be treated as gainfully employed)(**20**) of the Carer's Allowance Regulations, for "£139", in both places where it occurs, substitute "£151".

#### **Amendment of the Carer Support Payment Regulations**

- 7.—(1) The Carer Support Payment Regulations are amended as follows.
- (2) In regulation 14(1) (earnings limit), for "£139" substitute "£151".
- (3) In regulation 16(1) (amount and form of Carer Support Payment), for "£76.75" substitute "£81.90".

#### **Amendment of the Child Disability Payment Regulations**

- **8.** In regulation 23 (amount and form of Child Disability Payment)(21) of the Child Disability Payment Regulations—

  - (a) in paragraph (1)(b), for "£1,178.75 substitute "£1,257.75",
  - (b) in paragraph (4)(b), for "£23.75" substitute "£25.35",
  - (c) in paragraph (6), for "£143.85" substitute "£153.50".

# **Amendment of the Scottish Child Payment Regulations**

11. In regulation 20(1) (value and form of a Scottish child payment)(24) of the Scottish Child Payment Regulations, for "£25.00" substitute "£26.70".

#### **Amendment of the Winter Heating Payment Regulations**

12. In regulation 9(1) (value and form of winter heating payment)(25) of the Winter Heating Payment Regulations, for "£55.05" substitute "£58.75".
