

# Papua New Guinea, Western Samoa and Nauru (Miscellaneous Provisions) Act 1980

## **1980 CHAPTER 2**

An Act to make provision in connection with the attainment by Papua New Guinea of independence within the Commonwealth and with the membership of the Commonwealth of Western Samoa and Nauru. [31st January 1980]

#### 1 Commonwealth citizenship.

- <sup>F1</sup>(2) It is hereby declared that Papua New Guinea has never been a colony within the meaning of the <sup>M1</sup>British Nationality Act 1948.
  - (3) In accordance with section 3(3) of the <sup>M2</sup>West Indies Act 1967 it is hereby declared that this section and section 3(2) below extend to all associated states.
