BRITISH CITIZENSHIP

Acquisition after commencement

[^{F1}4B Acquisition by registration: certain persons without other citizenship

- (1) This section applies to a person who has the status of-
 - (a) British Overseas citizen,
 - (b) British subject under this Act, ^{F2}...
 - (c) British protected person.[^{F3}, or
 - (d) British National (Overseas)]
- (2) A person to whom this section applies shall be entitled to be registered as a British citizen if—
 - (a) he applies for registration under this section,
 - (b) the Secretary of State is satisfied that the person does not have, apart from the status mentioned in subsection (1), any citizenship or nationality, and
 - (c) the Secretary of State is satisfied that the person has not after [^{F4}the relevant day] renounced, voluntarily relinquished or lost through action or inaction any citizenship or nationality

[For the purposes of subsection (2)(c), the "relevant day" means-

- $F^{5}(3)$ (a) in the case of a person to whom this section applies by virtue of subsection (1) (d) only, 19th March 2009, and
 - (b) in any other case, 4th July 2002.]]
