SPEED LIMITS

Provisions as to directions under s. 82(2)

- (1) [F1A direction under section 82(2) by the [F2national authority] shall be given] by means of an order made by the [F2national authority] after giving public notice of [F3the national authority's] intention to make an order.
- [^{F4}(2) A direction under section 82(2) by a local traffic authority shall be given by [^{F5} a strategic highways company or] by means of an order made by [^{F6}the company or] the authority.]
 - (3) Section 68(1)(c) of this Act shall apply to any order made under subsection (2) above.
- [^{F7}(4) The power of the Welsh Ministers to make an order under subsection (1) is exercisable by statutory instrument.]
